A rough-in inspection is required before any work is covered and a final inspection is required when all work is complete. A twenty-four hour notice is required for any inspection. This signed application constitutes consent on the applicant's part to allow for all inspections at the property location listed.

Permits will not be issued until all of the required information has been furnished and all conditions mentioned above have been met.

INSPECTIONS REQUIRED: (24 HOUR NOTICE REQUIRED)

- 1. When under slab piping has been installed
- 2. When rough-in is complete and visible (Rough)
- 3. When job is complete (Final)

Building Inspector approval certifies that the applicant can proceed with installing Electrical fixtures in accordance with the specifications submitted. Any deviation from the specifications submitted will require an amendment to this permit or additional permits.
