Sunburns: How Harmful Can They Be?



Elizabeth West, an 8th grader at Merrimack Valley Middle School, is working on her Girl Scout Silver Award. One of the requirements in order to earn the award is to complete a project for the community that has a lasting impact.

Elizabeth's project was on Sun Safety for the Merrimack Valley School District. She selected this project after she incurred a serious sunburn at a school event where no shade had been provided and she had not brought any sun screen. This project meant a lot to her because she wanted to help prevent other kids from also receiving sun damage in the future.

To start the project off, she did a lot of research on the importance of sun protection and safe sun practices. She enlisted the help of her neighbor, Mrs. Pike, to be her mentor and community expert on safe sun exposure. Elizabeth developed a safe sun policy and recommendations for the school system to incorporate. She and Mrs. Pike met with Mrs. Barry, Assistant Superintendent, Mrs. Severance the Principal of MVMS, and Mrs Jones the MVMS nurse, to review the proposal and recommendations for a new district safe sun policy.

The meeting was a success and the district is in process of implementing some of the recommendations that Elizabeth made, specifically, to provide shade areas for school events, to send home notices prior to events to notify parents of the need of sunscreen and proper outdoor clothing. The district will also incorporate some of the Elizabeth's research on safe sun practices on the districts web page. Elizabeth made up posters on the importance of sun screen which are hung at the Middle school and created handouts that the district can give to parents and students on the importance of safe sun exposure.

As part of the project, Élizabeth contacted sunscreen companies for free samples of sunscreen. Badger sunscreen, which is an organic sunscreen made in NH, gra-Sunscreen — continued on page 16 Elizabeth West, an eighth-grader at Merrimack Valley Middle Schhool, works on her Girl Scout Silver Award.

A nother great D.A.R.E. year has come to an end and this fifth grade class has been an excellent class to teach.

This year, D.A.R.E. has implemented a new class program called Keepin' It REAL. The students worked through different situations using the new problemsolving model, Refuse, Explain, Avoid and Leave.

On May 29, 2013 we had our community clean-up day at the Recreation Field and Safety Building. The kids worked hard at picking up trash and making the area look great. After we were done, we had a picnic lunch, played games, and enjoyed our last time together as a D.A.R.E. class.

This year, we did things a little differently. Instead of using the golf cart, the students used the Fatal Vision goggles and saw just how hard it was to perform some standard field sobriety tests. They got a better understanding just how alcohol impairs their ability to walk and stand, and agreed that if they could not do that, driving a vehicle was out of the question!

Graduation was held on May 22, 2013 with our guest speaker Dan St. Hillaire, former Merrimack County Attorney. Dan provided first-hand knowledge as a prosecutor of what would happen should someone be arrested and prosecuted, for driving under the influence of alcohol, and or drugs.

As always, the Loudon Police Department is a community-based Department and we are here to serve you. D.A.R.E. does not stop here. It is my hope that parents continue to teach the children the dangers of alcohol and drug use, and help to reinforce the children with their positive decision making. Summer is finally here! A few notes of interest:

• School has ended for the summer. Children will be out and about on their bicycles, skateboards, etc. Please use extra caution on the roadways.

• Amanda Bullock is on duty as our lifeguard as reported last month. A reminder: She will be on duty Wednesday through Sunday 10:00 a.m.–6:00 p.m. We remind you that it is swim at your own risk. We ask that you supervise your children. Many times we see young children dropped off with no adult supervision. Also, a resident sticker is required to use the beach. You may obtain one at the transfer station during regular business hours. No alcohol or dogs are allowed.

• There is a town ordinance for curfew on town owned property. No one is to be on town property between the hours of 10:00 p.m. and 5:00 a.m. nor is any alcohol allowed at any time.

• Vacation time is here — remember to put a hold on your mail/newspapers or have a trusty neighbor or relative pick them up daily. We also recommend timers for lights in different areas of your home and to secure any vehicles left at the residence. Feel free to contact us to do extra checks of your residence while you are away.

The boys were honored to walk in the Loudon Memorial Day parade. Thanks to everyone who came out.







What's Cookin'! This month: Red, White, and... Blueberries!

Hail to the red, white, and blueberry. These tiny little blue gems do indeed pack a potent punch. They rank as the highest of any fruit for antioxidants, and one cup delivers 14% of the recommended daily dose of fiber and nearly a quarter of the recommended daily intake of vitamin C. Blueberries are also low in calories fewer than 100 for a full cup. This plump berry is celebrated throughout July, which is National Blueberry Month and the peak of its harvest. The fruit received an unofficial presidential seal of approval after Ronald Reagan insisted on having blue jelly beans at his inauguration, leading the Jelly Belly company to introduce its blueberry flavor.

RED, WHITE AND BLUEBERRY DELIGHT

This is a recipe I found on a label in the front of an old cookbook that was passed down to me. It had been taken off a can of sweetened condensed milk A little bit of research found it to be from 1976... I love old recipes!

- 1 can (14 oz.) Eagle Brand Sweetened Condensed Milk
- 1/3 cup ReaLemon Reconstituted Lemon Juice
- 2 teaspoons grated lemon peel
- 2 cups (1 pt.) plain yogurt
- 2 cups miniature white marshmallows
- 1/2 cup chopped pecans
- 1 pint fresh strawberries, sliced and well drained
- 1 cup fresh or frozen blueberries, well drained

In large bowl, combine sweetened condensed milk, lemon juice and lemon peel; mix well. Stir in yogurt, marshmallows and nuts. In 13×9-inch baking dish, spread half the sweetened condensed milk mixture. Arrange half the strawberries and blueberries on top, cover with remaining sweetened condensed milk mixture and top with remaining fruit. Cover with foil; freeze until firm. Remove from freezer 10 minutes before cutting. Makes 15 servings.

COOKIE CRUST BLUEBERRY PIE — blueberry-recipe.com Cookie Crumb Crust:

- 2 cups fine vanilla wafer crumbs
- 1/2 cup melted butter
- 1/3 cup sugar

Combine all ingredients; press over bottom and up sides of 9-inch pie plate. Bake at 400° for 10 minutes. Cool then fill.

Filling

- 6 cups fresh blueberries, divided
- 1/4 cup sugar
- 2 tablespoons water
- 2 tablespoons cornstarch
- 1/4 cup cold water
- 1 tablespoon butter
- 1 tablespon lemon juice
 - whipped cream or purchased whipped topping

Combine 2 cups berries, sugar and 2 tablespoons water in large saucepan; bring to a full boil. Dissolve cornstarch in 1/4 cup cold water; add to blueberry mixture. Return to the boil, stirring constantly.

Reduce heat to low and cook, stirring, for 2 minutes. Remove from heat. Stir in butter, lemon juice and remaining 4 cups of blueberries. Spoon into crumb crust. Let stand 3 hours until set. Serve with whipped cream or topping. Serves 8.

Quick tip: Use a store bought cookie crust in place of the homemade version.

EASY WHITE CHOCOLATE BLUEBERRY BISCOTTI — blueberry-recipe.com

- 1 pkg. (18.25) blueberry muffin mix with can of blueberries included
- 3/4 cup all-purpose flour
- 1/2 cup (1 stick) butter, melted and cooled slightly
- 2 large eggs, slightly beaten

2 cups (12-oz. pkg.) NESTLÉ TOLL HOUSE Premier White Morsels, divided Preheat oven to 350° F. Grease 2 baking sheets. Drain berries; set aside. Com-

bine muffin mix, flour, butter and eggs just until combined in large bowl. Fold in 1 1/2 cups morsels and drained blueberries with floured hands. Shape half of the

dough into a 12-inch-long roll (dough may be sticky). Place on a prepared cookie sheet; flatten slightly until about 2 inches wide. Repeat with remaining dough.

Bake for about 25 minutes or until a wooden toothpick inserted near the centers comes out clean. Cool on baking sheets on wire rack for 1 hour.

Cut each roll diagonally into 3/4-inch slices with serrated knife. Place slices, cut sides down, on un-greased baking sheets.

Bake for 10 minutes. Turn slices over and bake 6 to 8 minutes more or until light brown (do not over bake). Transfer to wire racks and let cool.

Place remaining morsels in small, heavy-duty plastic bag. Microwave on HIGH (100%) power for 20 seconds, knead bag to mix. Microwave at additional 10- second intervals, kneading until smooth. Cut a small hole in corner of bag; squeeze to drizzle biscotti. Let stand until the chocolate is set. Store in an airtight container at room temperature up to 24 hours or freeze up to 3 months for longer storage.

BLUEBERRY PEACH SMOOTHIE RECIPE — blueberry-recipe.com

Delicious Blueberry Peach Smoothie Recipe. Great for breakfast or as a smoothie snack anytime!

- 1 cup frozen peach slices
- 1/4 cup fresh or frozen blueberries or raspberries
- 1/2 cup lowfat vanilla yogurt1 tablespoon wheat germ

Place banana, frozen peach slices, blueberries, yogurt and wheat germ in a blender and process until smooth. Serves/makes 2

BLUEBERRY SAUCE — blueberry-recipe.com

- 1/4 c. confectioners sugar
- 1/4 tsp. each cinnamon and nutmeg
- 2 tsp. cornstarch 2/3 c. water
- 2/3 c. water Pinch of salt
- pt. (1 lb.) blueberries, washed and picked over
- 1/2 lemon, juiced

Lemon zest, grated

Place sugar, spices and salt in a heavy saucepan. Dissolve cornstarch in 1 tablespoon water and add to saucepan. Heat to boiling, reduce to simmer and stir to smooth. Add blueberries and cook over moderate heat until smooth and thick, 20 to 30 minutes. Taste and add more sugar if needed. Add lemon juice only to taste; you may not want to use all of it. Add zest to taste. Serve warm or cold.

HINT: Lemon zest is the bright yellow top layer of the skin. When grating, try to avoid the bitter pulp that lies beneath the zest.



ciously donated 20 bottles of sunscreen. The sunscreen has been given to all the schools in the district for students to use. The Loudon Recreation Committee supported Elizabeth's project and bought individual sun screen packets from Sun Buddy, an organic sunscreen, which Elizabeth gave out along with a handout on the importance of sunscreen at the Loudon Bicycle Safety Day as well as at the yearend Girl Scout Bridging ceremony.

The following are some critical facts on the importance of safe sun protection: While clothing provides some protection, a standard white t-shirt only has an

SPF of about 7. If it's wet, the SPF can go down as low as 3. The darker and thicker the clothing, the more protection it provides (Source: National Cancer Institute).

- People who first use a tanning bed before age 35 increase their risk for melanoma by 75 percent.
- A person's risk for melanoma doubles if he or she has had more than five sunburns at any age.
- One or more blistering sunburns in childhood or adolescence more than double a person's chances of developing melanoma later in life.
- Up to 80 percent of the Sun's UV rays penetrate clouds, so your chances of getting a sunburn on a cloudy day are quite high
- Just one indoor tanning session increases users' chances of developing melanoma by 20 percent, and each additional session during the same year boosts the risk almost another two percent.
- People who tan indoors just four times per year increase their risk of basal cell carcinoma and squamous cell carcinoma by 15 percent.
- Just one indoor tanning session per year in high school or college boosts the risk of basal cell carcinoma by 10 percent. That risk is increased to 73 percent if one tans six times per year.

265:108a - Parade Vehicles

- I. NO person may operate a vehicle in a parade unless the following safety precautions are taken:
 - 1. No person may use any type of vehicle with protruding or outrigger wheels in a parade unless the vehicle is suitably modified to protect both riders and pedestrians from the wheel assembly.
 - 2. At least one adult, other than the driver, shall supervise children riding on a vehicle in a parade and have a reasonable means of immediate communication with the driver. The number of adults supervising the children shall not be less than one adult per every four (4) children and sufficient to ensure that each child is visible to a supervising adult.
 - 3. Children riding on a vehicle in a parade shall remain entirely within the perimeter of the vehicle and, if standing, shall be reasonably protected from probable injury if the vehicle suddenly starts or stops.
- II. Any person operating a vehicle without following all of the safety precautions listed in the above paragraph (I.) shall be guilty of violation and shall be subject to the following fines:
 - (a) \$50.00 for the first offense.
 - (b) \$100.00 for a second or subsequent offense.



2. Minutes of Previous Meetings:

Motion by Normandie Blake, second by Laura Vincent, to approve the April 8, 2013 Board Meeting minutes (pages 1–6 in the packet) with one correction. Motion passed unanimously.

3. Financial Report:

Robin Heins briefly reviewed the overages detailed in the FINANCIAL REPORT (page 7 in the packet) and reported that everything is going fine. *Motion by Will Renauld, second by Normandie Blake, to accept the financial report as presented* (pages 8–21 in the packet). Motion passed unanimously.

4. Public Participation:

Thomas Godfrey reminded everyone that Public Participation is not a Public Hearing.

Emily Reagan, MVHS Student Representative, reported on activities and sports at the high school. It was noted that tonight is Emily's last report to the board. The board thanked Emily for her reports while serving as the MVHS Student Representative.

Roy Merrill, Loudon resident, discussed information related to superintendent salaries throughout New Hampshire.

Thomas Godfrey read the following statement in response to public comments and questions about the superintendent's salary:

The MV School Board has heard and understands the concern some members of the public have voiced regarding the Superintendent's compensation. The Superintendent's compensation structure was changed by the SAU Board (made up of the Merrimack Valley School Board and the Andover School Board) when he retired and went from full time to part time in 2009. It was modified again when the law changed in 2012. This last change involved reducing the contracted hour agreement from 34.5 hours per week to 32 hours per week.

At that time, after assessing the entire situation, the SAU Board agreed to maintain the same level of weekly compensation while reducing the contracted hours from 34.5 to 32. It is very common in the both private and public sector, especially during transitional periods, for employees that change from salary to hourly or vice-versa to be compensated at a level which will not result in a compensation decrease during that transition. Keeping our long-time, fully engaged part-time Superintendent's compensation "whole" was a 10% raise on paper only. We are paying NO ADDITION-AL BENEFITS, which in most cases equal approximately 30% of the salary. In our case, we have one of the most experienced and respected superintendents in the state willing to remain fully engaged and loyal only to SAU 46, as a part time employee on a short term. This "short" term has extended slightly at the request of, and benefit to the SAU Board. The extent of Dr. Martin's experience, certifications, skills and knowledge are the reasons why this part-time position works. This arrangement allows Dr. Martin to focus on and work solely for SAU #46.

The SAU Board feels very strongly that this was fiscally appropriate after reviewing surrounding districts, and we believe time has shown it was the right decision. The MV School Board looks forward to working with Andover School Board as we begin our search for Dr. Martin's replacement and we look forward to working with Dr. Martin through this critical transition.

Ken Ross-Raymond, Salisbury resident, encouraged the board to look for a part-time superintendent.

Roy Merrill, Loudon resident, commented about another school district's superintendent.

Ken Ross-Raymond, Salisbury resident, asked how to add something to the school board meeting agenda.

Karen Sheldon, Salisbury resident, asked how do we get answers.

Ken Ross-Raymond, Salisbury resident, asked about progress in getting answers/ quotes from transportation companies.

The Library Director's report was reviewed. This included the following:

• The New Hampshire Downloadable Books consortium met on May 2 in Plymouth to discuss changes in assessing member rates. The formula includes population and amount of circulation. Using an online survey to the 192 member libraries in the state, NHDB will make further decisions regarding number of electronic copies to buy when wait lists are long, loan period, and types of always available books.

- Some plumbing repairs are needed in the Children's Room.

- Summer Reading Program sign-ups will begin on the Saturday after school closes for the summer.

Chairman Krieger called the meeting to order at 6:00 P.M.



Chairman Krieger opened the Board of Permit.

Chief Fiske had five Hawker and Peddler permits. They were for Speedway Convenience, Speedway Sports Park, Brookside Mall, Dudley's Ice Cream and Z-1 Express. Chief Fiske said all paperwork is in order.

Chief Fiske also had a permit for the Loudon Food Pantry. They will be holding a 50/50 raffle for the month of June. They have requested, as they have in the past, that the fee be waived. Chief Fiske said that he spoke to Steve Raper from ESMI. Mr. Raper asked if it is necessary to continue sending the monthly reports to the Town of Loudon or could it be done on a quarterly basis. Chief Fiske stated that Donna reviewed minutes and it was Zoning that required monthly reports. He said that the latest one that they received was for four months. Chief Fiske said they have been in compliance, no issues. Dave Powelson asked if the report says where the soil is going. Chief Fiske said yes, how many tons they've processed, how many tons have left and any compliance issues. Mr. Powelson said it seems to him that they are doing a pretty good job. Selectman Ives agreed, saying that we haven't had any issues in the last few years. Selectman Ives stated that since the report was a requirement of the Zoning Board that it would be up to them, he doesn't believe this Board has the authority to modify their requirement. Chief Fiske will inform them that they need to seek an answer from the Zoning Board.

Chief Fiske said that the owner of Lazy Pines asked if it's permissible to allow someone else to live in his house and allow him to stay in his 5th wheel camper for 2-3 months. Mr. Powelson said that is a little like camping. Stan Prescott asked if he would be on a lot or in the driveway. Chief Fiske said in the driveway. Mr. Prescott asked if there is a vacant lot in the park. Chief Fiske said not that he is aware of. Selectman Ives recalls that the ordinance has a limit as to how many days someone can stay in a camper. Mr. Powelson stated that in the definition of camping in the ordinance it says 21 days. Mr. Prescott read from the 503.3 in the Zoning Ordinance that temporary camping or campgrounds are not

permitted in any district except that of local civic organizations and youth groups. Chief Fiske read also from 503.3 This section shall not be construed to limit the owneroccupant of a residence served by adequate sanitary facilities from accommodating, without compensation, occasional overnight guests in tents, recreational vehicle, or campers placed temporarily within the yard of such residence. Chairman Krieger said that 3 months doesn't sound temporary to him especially if it's going to happen every year. Selectman Ives said it also doesn't sound like it's occasional. Chief Fiske said this has been done before and what they do is stay for awhile, leave for a week and then come back. Selectman Ives said he is afraid that if they allow this to happen for 3 months then a lot of people will go south for the winter and come back up to stay at junior's house for the summer in a camper. Mr. Prescott said he'd like to see if there is a vacant lot in there to set it on. Chairman Krieger said they need to find out what is right or wrong, if it can only be 21 days, does it make it wrong because it's his camper on his property and he's renting out his house, does it make it wrong for him to stay in his camper for three months? Selectman Ives said he thinks no and if he has a problem with that to see zoning. Mr. Powelson said he doesn't see where it fits with zoning. Selectman Ives said that if he has a vacant lot in the park, put the camper there and there would be no problem but he can't see putting it in the driveway.

Chief Fiske said that the Beanstalk store is close to getting the Subway and they have submitted a sign application. They don't want to put up a free-standing sign; however they want the word Subway on the 106 side of the store and another on the north side of the store. Chief Fiske said those signs would be 30 square feet each, 60 square feet is permissible for a business not



part of a shopping center. Selectman Ives asked if the sign will be lit. Chief Fiske said it will be. Mr. Powelson clarified that a business may have a sign attached to the front façade as large as the area permitted by S.501.1 which is 60 feet. He said this building has a front façade and a north façade and he doesn't see an issue with having the same size sign on the two sides of the building. Selectman Bowles pointed out that according to 501.2 B they would have to see the Zoning board for a special exception to put a sign on the side of the building. Mr. Powelson agreed, they can put the sign on the front at any time but they have to see zoning for the one on the side. Selectman Ives said he sees no problem with either sign but they will need to go to zoning.

Mr. Powelson explained that Donna received a question from Neuro Restorative about putting a fourth person in the garage. Mr. Powelson read the following from the Board of Permit minutes of June 12, 2012 Chief Fiske stated that he spoke to representatives of 45 Hemlock Hill; they want to convert an office space into a fourth bedroom, they are aware they will need to deal with updating the septic if adding a bedroom. Selectman Ives feels that they misrepresented themselves by saying three clients and now asking for another one. Mr. Prescott stated that it's turning from a home into a facility. Chief Fiske will look further into the statutes and the number of clients allowed in the home. Chairman Krieger recognized Kathy Drown, Program Manager of the group home Neuro Restorative. Ms. Drown explained that right now they are a certified facility and they are looking to become a licensed facility. She explained that their group home in Chichester is licensed and they would like to be consistent. Ms. Drown explained that to become licensed they have to be licensed for a minimum of four beds. She said that at this time there is no plan to put anyone in the fourth room. Ms. Drown said that the rooms are already built, they are offices. Chairman Krieger suggested that Donna get the town's attorneys opinion about this since he was involved in it previously, Mr. Powelson agreed that it should start with the attorneys opinion. Chairman Krieger asked Ms. Drown to contact Donna and get her the information about the licensing so she can get it to the attorney. Ms. Drown agreed. Mr. Prescott said that one of the biggest concerns is the septic system if a fourth bedroom is added.

Chairman Krieger closed Board of Permit

The Board met with Chief Wright.

Chief Wright said that he got certificates from the job applicant and gave them to Chief Fiske.

Chief Wright said they had the open house on Saturday, they estimate that over 400 people attend.

Chief Wright said that the new fire apparatus was supposed to be driven up last week but it wasn't. Chief Wright said he called the dealer and told him he was unhappy with the delivery and unhappy that they weren't telling him what was going on. Chief Wright said he was told he would have it next week.

Chairman Krieger asked Chief Wright to thank everyone at the Fire Department for the open house.

Chief Fiske gave the Selectmen information regarding the applicant for the Fire Chief position. Chairman Krieger asked Chief Wright to review it and get it back to the office. Chief Fiske asked Chairman Krieger who would maintain the background records. The Board agreed that the files should be part of the personnel file at the Selectmen's Office. Chief Fiske requested that someone sign off when he turns them over. Discussion ensued about where the files are kept at the Selectmen's office and who has access to them. Chairman Krieger said that they will look into it before making a decision about these records.

The Board met with Road Agent, Dave Rice.

Mr. Rice said that everything is going well, they've been grading.

Mr. Rice said they have been ditching Mudgett Hill.

Mr. Rice said that he spoke to three people about asphalt as far as the road work for this year. He said he has asked them to give him a tonnage price as well as a total. He said he has also asked for a price to top Bee Hole hopefully the end of May the first of June.

Mr. Rice said they are mowing the ball fields but as soon as they get done they look like they need to be done again.

Selectmen Ives asked if we have received any bids for the flail mower. Mr. Rice said the bids are due next Tuesday and haven't got any yet.

The Board met with Brenda Pearl, Office Manager.

Brenda explained that she met with Bill Bald from Melcher and Prescott regarding the employee's health insurance renewal. She explained that the dental insurance has increased 1.2% and if we stay with the health insurance policy that we have now it will increase 16.67%. If we raise the health deductible from \$3,000.00 to \$4,000.00 it would be an increase of 7.71%. Chairman Krieger confirmed that other than the deductible the policy remains the same. Chairman Krieger stated that they had budgeted for a 12.5% increase. Chairman Krieger asked about the increase per pay period for the employee, Brenda said with the 7.71% increase and the 1.2% increase the employees would be paying a few more dollars per week. The Board confirmed that the deductible will be increased to \$4,000.00 with the employee paying the first \$500.00 and the town paying \$3,500.00, the town will pay \$9,000.00 plus 90% of the balance of the premium with the employee paying the rest. Selectman Ives made a motion to approve the Anthem health insurance plan HPNEVP58VE. Seconded by Selectmen Bowles. Chief Fiske asked how the copays are affected. Selectman Ives confirmed that they remain the same as the policy we currently have. All in favor. Motion carried.

Chief Fiske stated that he received an application from Ron Lane. Mr. Lane explained that the application is for junk plates, he now has repair plates. Mr. Lane said he is required to have a junkyard permit and needs the application signed saying that he has one in order to get the junk plates. Chief Fiske verified that his junkyard permit expires July 1, 2013. The Board reviewed the application and signed it.

Selectman Ives said that there was a camper that stayed at a campground all winter. He asked if they can stay there year round. Chief Fiske asked what would prohibit it. Selectman Bowles said that they would have to find out if it is approved as a seasonal campground. Selectman Ives said it was reported to him that log trucks have been seen coming out of there and he doesn't recall them signing a timber cut permit for them. Chairman Krieger asked if they need an intent to cut if they are cutting trees near campers. Chief Fiske said negative. Selectman Ives said they do if they are cutting to expand the area. He said he also heard they are filling in wetlands. Chief Fiske said there has been controversy for many years as to how many campsites there

are there. Selectman Ives explained that he has held back on this issue because of his history there but this information has come to him through different sources. Chief Fiske said that the State is after them right now because their dumpster falls in the state right of way. Chief Fiske said in his opinion that it would be appropriate for Mr. Wiley, Town Assessor, to go there and document what is there now. Chairman Krieger asked what they are going to do about the wetlands. Selectman Ives said that he wants to be sure that the town knows what expansion has been done so they are being taxed properly for it. Chief Fiske said that he would be glad to go with Mr. Wiley and take pictures. Chairman Krieger said after they take a look at it they will determine if they need to contact DES.

The Board began their review of weekly correspondence.

The Board received a letter from the State of NH regarding a FEMA payment for the November 4, 2012 storm. The Board will review the information and sign the form next week.

The Board received a report from ESMI for the first quarter 2013 Host Community Fee.

The Board received the ESMI self report for January through April 2013.

The Board received an overdue ambulance bill for review. Selectman Ives made a motion to send the following ambulance bill to collection: account #866 in the amount of \$594.80. Seconded by Selectman Bowles. All in favor. Motion carried.

The Board received a copy of the updated office hour's list. The only change to the office hours is the Town Clerk's. She will be closing at 8:45 p.m. due to the time that the State of NH DMV support closes. The Board received a letter from Edge Point regarding uncollected monies.

The Board received a copy of the April property transfers.

The Board received a memo from Bonnie regarding the rental of the Community Building. The building was not left in good shape and she spent time cleaning it. Chairman Krieger said that they have the security deposit; he suggests keeping it because if she hadn't cleaned it and the town had to pay someone it would have cost more than that. Selectmen Ives and Bowles agreed. Chairman Krieger said the deposit check will be deposited and a letter written to the renters explaining that due to the condition that they left the building; expenses were incurred, the deposit will go towards cleaning and they won't be renting to them again. The Board received a copy of the check received from ESMI for the 1st Quarter 2013 Host Community Fee in the amount of \$12,960.21.





Selectman Bowles thanked everyone for participating in the Memorial Day parade, there was a good turnout. He appreciates all that the department heads do to make it a good event for the townspeople.

The Board met with Road Agent Dave Rice.

Mr. Rice said they are still working on grading roads.

Mr. Rice said they are trying to keep up with the mowing. He ordered the new flail mower; it should be here in a couple of weeks. The Board met with Police Chief Bob Fiske.

Chief Fiske said that Cystic Fibrosis will be back in town June 8 and 9. The Fish and Game have approved the off road trail bike ride.

Chief Fiske explained that Harley-Davidson wants to do demo rides June 11-15 from 9 a.m. to 4 p.m. Chief Fiske submitted a copy of the route for the rides. He said it uses part of Gues Meadow Road, a small portion of Clough Hill Road, all of Lower Ridge Road and half of Loudon Ridge Road. Chief Fiske stated that there was concern a few years ago: there was a little havoc caused up on the ridge. Bob Butler and Pauline Touzin represented the Conservation Commission.

Acceptance of Minutes:

April 18, 2013 Regular Meeting — Henry Huntington moved to accept the minutes as written; seconded by George Saunderson. All were in favor.

May 7, 2013 Site Visit — Stan Prescott made a motion to approve the minutes of the Kara Realty site visit; seconded by Bob Cole. All were in favor.

Discussion:

Steve Chabot of Keach-Nordstrom — Mr. Chabot explained that his company is

working on a gas main extension plan. They are working with DOT, District 3 to cross Route 106 at Staniels Road. He has talked with Road Agent Dave Rice and tonight submitted a plan to be given to Mr. Rice. The gas line will go under Route 106, down Staniels Road to the east side of Veteran's Drive, along the length of Veteran's Drive into Concord, and then cross the river to Pembroke. Mr. Chabot stated that borings have been done to determine the most suitable path. They will be tying into the gas line west of Josiah Bartlett Road, and this will be an 8" pipe with 3' of cover. Mr. Chabot explained that this is between Liberty Utilities and Continental Paving. He spoke about the permits needed and the timeframe of 6–8 weeks before the actual construction begins. Mr. Chabot spoke about the lines that run under Staniels Road

from the Red Roof Inn; these will be marked out by Dig Safe. Frank Merrill said he has talked with Continental Paving and will hold off on the final top coat on Veteran's Drive until this work is done. Stan Prescott said he would like to see this line laid beyond the 4' shoulder. Mr. Chabot agreed that they could work with 5', assuring the Board that the shoulder would be repaired to the way it was when they start. The Board thanked Mr. Chabot for the information.

Conceptual Consultation:

New England Flower Farms - Henry Huntington stepped down from the Board. Tim Bernier of T.F. Bernier, Inc. represented New England Flower Farms. He explained that they are proposing to construct a new greenhouse to replace the final Quonset hut greenhouses. A lot line adjustment will have to be done in order to meet the 10% coverage requirements. Mr. Bernier explained that they will be impacting some wetland; this is currently lawn but is hydric soil. There is a plan to connect buildings with a covered enclosure: overhead doors would allow trucks to pass through the connector. Henry Huntington stated that they will be taking 20,000 sf down and putting 50,000 sf up. He said there is not much else that can be done on this property once this project is complete. It was noted that most traffic has been re-routed to the new access by the town line. Pauline Touzin asked if there would be chemical fertilizers in the drainage water. Mr. Huntington explained that most of the drainage is rainwater off the roof. He said most of their pesticides are contact and there is very little run-off of pesticides. Mr. Huntington stated that they have flood floors and floor drains and they try to recycle any water from there. The Board had no questions or concerns with the conceptual plan.

Application #13-04, TTD, LLC — Major Subdivision on Route 129 & Pittsfield Road in the RR District, Map 25, Lot 5. Jeff Green submitted a request to continue the application to give them time to gather more information. Tom Moore made a motion to continue the application to June 20, 2013; seconded by George Saunderson. All were in favor. The meeting will be at 7:00 p.m. in the Community Building; there will be no further notification.

Application #13-05, Kara Realty Associates — Major Site Development on Veteran's Drive in the C/I District, Map 1, Lot 64. Tim Bernier of T F Bernier, Inc. represented applicant Frank Merrill. There were no abutters present; applicants Frank & Sue Merrill were present.

Henry Huntington made a motion to accept this application as complete and move to public hearing; seconded by Bob Cole. All were in favor. Mr. Bernier pointed out that they have changed the front setback from 100' to 60' and added more landscaping since the last meeting, noting that the trees are a mix of shade trees and evergreens. He stated that bollards have been added at the garage doors and lights on the sign have been added to the detail sheet. Mr. Bernier explained that they were able to move the building ahead 10' which helped a lot; the retaining wall can now be straight and the impervious surface is less. They moved the leachfield forward 10' as well. Mr. Bernier said they have the same number of parking spaces, noting that the upper driveway is one way in and along the building.

Pauline Touzin asked about the maintenance that would be done onsite. Frank Merrill explained that they would be doing routine work such as changing oil. He said they would capture the used oil and put it in a tank to be sold. He gave an overview of what they do at their current location in Pembroke with regard to using the used oil in their furnace, storing used anti-freeze to be taken away by a company, inspections by DES, etc. He said they use Best Management Practices. Mr. Merrill explained that the mechanic's truck may be there overnight but the construction vehicles are parked at his pit.

Tom Moore asked about the leaching basin chamber. Mr. Bernier explained that there will be gutters on the building and the plan is to trap as much run-off as possible in order to avoid it going toward the retaining wall. Henry Huntington asked about the note of that being temporary. Mr. Bernier explained that it is erosion control protection while the site is disturbed, thus the word temporary. Mr. Moore said that a guard rail along the wall was discussed at the site walk. Mr. Bernier said he will add this to the plan. Mr. Moore asked if the bounds are marked. Mr. Bernier spoke about the slopes and location of markers; he said he will add a description to the plan. Stan Prescott referred to Sheet 2 and asked if distances are all the way to the river. Mr. Bernier said they were. Tom Dow noted that all the information is on Sheet 1. Mr. Bernier said he will add tie courses and distances to all sheets. Mr. Dow asked if there are plans for the retaining wall. Mr. Merrill said they do not have them yet but will provide them to the office as soon as they are received.

Bob Butler said he would ask that they be careful not to take out any more than they have to as the roots are holding the bank. Mr. Merrill said they could use silt logs instead of silt fence as there would be less disturbance. Mr. Butler felt that would be a good plan.

Motion seconded by Tom Moore. All were in favor.

New Business:

Application #13-06, Inisfree Investments, LLC — Lot Line Adjustment on Chichester Road in the RR District, Map 11, Lots 12 & 41. Jeff Green represented the applicant. He showed an overview of the entire property, noting that Lot 11-12 is 122.95 acres and Lot 11-41 is .997 acres. Mr. Green explained that this adjustment would turn Lot 11-41 into a four acre lot that would encompass the scale house area. The remaining piece of the original Lot 11-41 would be added to Lot 11-12. This would put all buildings on one lot and cleans up the lines. Henry Huntington went over the changes to clarify. The lots will go from one acre to four acres and from 122 acres to 119 acres. Mr. Green noted that he will add a Z to connect the sections and a note about the lines to be abandoned.

Henry Huntington made a motion to accept the application as complete and move to public hearing; seconded by Bob Cole. All were in favor. There was no further discussion.

Tom Moore made a motion to approve the application as presented with the addition of the note about line to be abandoned; seconded by Bob Cole. All were in favor.

Application #13-07, Inisfree Investments. LLC — Minor Subdivision on Chichester Road in the RR District, Map 11, Lot 12. Jeff Green represented the applicant. Roy Merrill was present as an abutter (M2/L29). Mr. Green explained that State subdivision approval is pending for this one-lot subdivision. He pointed out that it is directly across from Bee Hole Road, next to two two-acre lots done by Mrs. Decato a few years ago. Mr. Green said there is 300' of frontage on the 3.009 acre lot, with 1.9 acres of buildable area. He noted that he found a small slope area and has marked the 25' and 75' wetland buffers. Mr. Green said that two test pits were done for the remaining land. He pointed out that he followed the same back lines as the two neighboring lots. He said he went over 300' because of a bog area. Henry Huntington made a motion to accept the application as complete and move to public hearing; seconded by Bob Cole. All were in favor.

Roy Merrill stated that he has a lot behind this one and had access through this lot. He said his concern is if the frontage is taken away then he would lose that access. Mr. Green explained that the access is not defined so the owners of the lots in the back have the right to pass where suitable. He said there will still be a lot of frontage left after this subdivision. Mr. Green said there was no road being used that could be found. Bob Cole asked how this should be handled and if the property owners at the back should go to the front owner for permission or get a ROW defined. Mr. Green explained that the right to pass and re-pass is in the related deeds. He said he could add Note #10 to address that there is an undefined

easement to access the lots in the back and that would follow through.

Tom Moore spoke about work that is being done on the transportation chapter of the Master Plan and how it is preferable to line up access points with others. He noted that this new lot would not allow that to be done with future access across from Bee Hole Road. Jeff Green explained that there is a bog/marsh area on this lot and it is not practical to plan a road around it. He said they could access the remaining land across from Wellington Lane on the more developable side of the parcel. There was discussion of wanting to see a conceptual plan for future build-out of this parcel before seeing much further development.

Chairman Dow read the following waiver requests:

Section 12.4.11: Bob Cole made a motion to grant the waiver; seconded by Henry Huntington. All were in favor.

Section 12.4.10: *Henry Huntington moved to grant the waiver; seconded by Tom Moore. All were in favor.*

He said they have been looking at access management, traffic counts, and other areas. The committee will be meeting in two weeks and they will have more solid details after that. Mr. Moore said they are looking for pictures of roads to put in the Master Plan. If anyone has areas of particular interest or concern, the pictures can be forwarded to the Planning office. Chairman Dow stated that the Board needs to get moving on other chapters of the Master Plan. Donna will talk with Mike Tardiff about this.

Report of the ZBA:

There are six applications on the agenda for Greenpeace Nominee Trust, five carried over from April and a new one for a variance. There is also an application for reduced setback and one for a home occupation/day care.

Report of the Board of Permit:

Stan Prescott reported that there was discussion regarding Neuro Restorative on Hemlock Hill Road wanting to put in a fourth bedroom in what is now an office in the garage. It was agreed to have the Planning office contact town counsel for confirmation of previously received information on related statutes. There were five Hawker & Peddler permits. Signage for the new Subway at the Beanstalk Store was discussed; they were referred to the ZBA for a special exception. There was an inquiry from a resident about being able to live in their camper in the driveway of their house for two or three months at a time; the house is currently rented out. It does not appear that there are such provisions in the Zoning Ordinance.

Adjournment:

Stan Prescott made a motion to adjourn at 8:40 p.m.; seconded by Dustin Bowles. All were in favor.

Zoning Board of Adjustment Meeting Minutes — May 23, 2013

Chairman Dave Powelson called the meeting to order at 7:00 p.m.

ROLL CALL

The following members were present: Chairman Dave Powelson, Howard Pearl, Ned Lizotte, Earl Tuson, and alternates Jim Venne and George Saunderson.

ACCEPTANCE OF MINUTES

Regular Hearing — Earl Tuson made a motion to approve the minutes of April 25, 2013 as written; seconded by George Saunderson. All were in favor.

Site visit — Earl Tuson made a motion to approve the minutes of the site visit for Greenpeace Nominee Trust as written; seconded by Howard Pearl. All were in favor.

DISCUSSION

John Reese — Mr. Reese came in to talk about the Lovejoy Farm Bed & Breakfast. He said the house has been empty for almost a year, and he was wondering if the special exception that was granted on the property was still good or if the process would have to be redone. He explained that there are five rooms and the carriage house that could be used. He said the plan would be to convert the barn to a function hall. similar to Dell Lea Country Club in Chichester, for weddings, conferences, etc. Chairman Powelson referred to a file on the property from 1994 when a six-room bed & breakfast was approved for Art Monty. He explained that special exceptions and variances are permanent and run with the land. Howard Pearl referred to Section 204.3 J, accessory uses, saying this would seem applicable for the function hall. George Saunderson said he would agree, adding that there would probably be conditions, such as hours, attached. It was felt that the proposed use could be considered under Section 204.3 J.

PUBLIC HEARING

Application #Z13-09, Jodi Doody — Special Exception for Reduced Setback, RR District, Map 12, Lot 12 on Bee Hole Road. Abutter Rob Radcliffe was present. Ms. Doody explained that there is currently a shed at the back of her property but the area is down over a slope and it is hard to get equipment up the hill. She said she wants to place a new shed at the side of the property for better accessibility. Ms. Doody described the area, noting that there are trees at the side that would limit pushing the shed back. She also pointed out the area of her septic system which would limit the placement.

Chairman Powelson went through the points of the application. Ms. Doody stated that she is proposing to use a shed that is 12' x 16' or smaller. The chairman asked if there were any abutters wishing to speak in favor of the application. Mr. Radcliffe stated that he got a special exception for his shed in 2004 and he is fine with this proposal. Ms. Doody explained that the shed would be placed slightly ahead of where Mr. Radcliffe's is located on the other side of the property line.

Chairman Powelson appointed Jim Venne as a voting member on this case in the absence of Roy Merrill. Howard Pearl made a motion to approve the application as presented with the front setback of 15' and the side setback of 20'; seconded by Ned Lizotte. A roll vote was taken: Jim Venne – Yes; Howard Pearl – Yes; Dave Powelson – Yes; Ned Lizotte – Yes; Earl Tuson – Yes. Unanimous – APPROVED.

Jim Venne returned to the Alternate position. George Saunderson was appointed as a voting member for the next case.

Application #Z13-10, Beth Mulleavey Special Exception for a Home Occupation/Day Care, RR District, Map 23, Lot 30 on Route 129. There were no abutters present. Mrs. Mulleavey explained that she has been operating as a pre-school. She has recently learned that the fire marshal requires commercial grade setup with fire alarm system, fire-rated walls, etc. if considered a pre-school. Mrs. Mulleavey said she is working with the State on day care licensing, and the fire department has inspected and they are in agreement with the numbers. There was discussion of the number of children. Mrs. Mulleavey explained that she would like up to twelve, noting that she falls within the State's requirements with square footage. Chairman Powelson read a letter from abutter Pat Chagnon who stated she was in favor of the application.

Chairman Powelson went through the points of the application with the applicant. There was discussion of hours and parking. Ned Lizotte made a motion to approve the application as submitted, changing the approval from a pre-school for up to six children to a day care for up to twelve children; seconded by George Saunderson. Jim Venne said he wasn't sure if the applicant was still in business as there has been no visible sign of a home occupation. Howard Pearl said that Mrs. Mulleavev has done a great job with the business and there has been no impact to the neighborhood. A roll vote was taken: Earl Tuson – Yes: Ned Lizotte – Yes; Dave Powelson – Yes; Howard Pearl – Yes; George Saunderson – Yes. Unanimous – APPROVED.

Applications #Z13-04 Special Exception for driveway in wetlands conservation district, #Z13-05 Special Exception for work in the 50' wetland buffer, #Z13-06 Variance for filling of wetlands, #Z13-07 Variance for ground disturbance within 75' wetland buffer, and #Z13-08 Variance for construction of building in steep slope district, #Z13-11 (new this month) Variance for Driveway on More Traveled Road, Greenpeace Nominee Trust — C/I & RR Districts, Map 61, Lot 2 on Route 106 & Asby Road. There were no abutters present. Jeff Lewis and Matt Routhier of Northpoint



Engineering and applicant Dave Pritchard were present. Ned Lizotte recused himself from this matter since he was not at the last meeting or site walk. Jim Venne was appointed as a voting member in place of Mr. Lizotte and George Saunderson was appointed as a voting member in the absence of Roy Merrill.

Jeff Lewis gave an overview of the applications. He said they would probably withdraw the applications for special exceptions if the variances are granted. Matt Routhier spoke about a discussion at the site walk about a vernal pool area. He said based on a letter from the Conservation Commission and the site walk, they have pulled the grading out of the buffer, leaving it untouched. He also pointed out a pocket of wet that is holding water on the lower portion of the lot. They are now proposing a wall to reduce the impact, providing more of a buffer. Mr. Routhier said these changes lower the impact from 18,000 sf to less than 500 sf +/-

Jeff Lewis spoke about the Phase 1 and 2 plans. He said that are not proposing any future development at this time so Phase 2 is only conceptual for the permitting process. He said once they get ZBA approvals for Phase 1 only they will go to the State for Alteration of Terrain and wetland permits. He said the pad site creation for future use would leave everything in order for when someone wants to do something with the lot. Dave Powelson clarified that they are asking for everything that will happen for Phase 1. Mr. Lewis said that was correct and that Phase 2 should not require any additional consideration by the ZBA.

Earl Tuson said he sees that they are adding to the slope on Phase 1 and then the plans show it removed on Phase 2. Jeff Lewis explained that they would put a wall up to allow additional room. Matt Routhier explained that the wall would be built as part of Phase 1. He said the numbers provided are for work to be performed in Phase 1 and there would no expansion of impact beyond that. Jeff Lewis said when Phase 2 happens the intent would be no more impacts as it would be within the footprint of Phase 1 disturbed areas. It was stated that there are 4.62 acres of buildable area on this 13 acre site.

George Saunderson noted that the Conservation Commission recommended an open bottom pre-cast concrete culvert. Jeff Lewis said they are agreeable to that but will have to go with what the State approves. Mr. Saunderson asked about a driveway permit for Route 106. Matt Routhier explained that they have learned that it is not a limited access area and have the right to put in a driveway. He said they will go through that process as they proceed. Mr. Routhier said a lot of the process is based on getting these variances. Howard Pearl asked if there would be a secondary access off Asby Road. Mr. Routhier said that is not anticipated as the road is not conducive to that much traffic. Earl Tuson stated that the State looks at a lot of record as of 1971 to determine how many drives are allowed.

Howard Pearl noted that the answers are about the same on all of the applications; he said in the interest of time maybe they could get the answers to all and ask questions on individual applications as they go along. Dave Powelson said he would like to go through them individually, looking at the first one clearly, then see what differences there might be on each additional one. It was agreed to go through the variance applications first.

#Z13-06, Variance for filling of wetland: Chairman Powelson went through the points of the application with Jeff Lewis. Mr. Lewis noted that the request is now for 8,604 sf as compared to 9,948 sf on the application. He also noted that the impact given in point #1 has been reduced from 4,254 sf to 2,910 sf for the driveway crossing. The chairman asked if the reduction in square footage reduces the overall percentage of impact. Mr. Lewis said it would not significantly reduce it; 96% would still be good.

Howard Pearl said the Zoning Ordinance allows for commercial development, and this is a challenging property where they have done a lot to minimize the impact. Howard Pearl made a motion to approve application #Z13-06; seconded by Earl Tuson. Earl Tuson said they have minimized the impact. Howard Pearl said the applicant has shown some willingness to work with the boards in town and has taken the appropriate steps to protect the wetlands by working with the concerns of the Conservation Commission. A roll vote was taken: Earl Tuson – Yes; Dave Powelson – Yes; Howard Pearl – Yes; Jim Venne – Yes, George Saunderson – Yes. Unanimous – APPROVED.

#Z13-07, Variance for disturbance within wetland buffer: Jeff Lewis said this is very similar with the criteria of Z13-06. He said there is a buffer impact of 2.42 acres; he gave an overview of the buffers. Chairman Powelson compared the responses for those of Z13-06. Howard Pearl referred to note #3 from the Conservation Commission with regard to a wall and plantings to protect an area. Matt Routhier said it was a reasonable request and it will be discussed when they meet with the Conservation

Commission again. Howard Pearl said the responses are pretty much the same. Jim Venne agreed. Dave Powelson reviewed the answers. Jeff Lewis stated that the percentage in #3 has been reduced from 38% to 36%

Earl Tuson noted that they had done well to stay out of the 25' buffer areas but then the seven parking spaces in the southern corner of the plan are very close to the 25' area. Matt Routhier said the final impact will depend on what it is used for and they have maximized it as much as they can since they lost ten spaces by a wetland. Howard Pearl said a little give and take is good as they have worked very hard in areas that the Conservation Commission was most concerned about. Jim Venne agreed. Jeff Lewis said the need for buffers was reduced with the gravel parking lot and drainage versus working around vernal pools. Howard Pearl made a motion to approve #Z13-07; seconded by Jim Venne. Earl Tuson said the seven parking spots could be put up back by the RR and C/I line. Matt Routhier said the slopes are steeper than 5% at the back area and he feels they can increase the quality of the buffer between the parking and wetland. Jeff Lewis said they could look at the idea, noting that the move may change numbers. He said if they could agree that the Board is comfortable with them working with the Conservation Commission to make the best decisions for the area then they would do so. Howard Pearl said he is comfortable with the plan as presented and he would always encourage applicants to work with the Conservation Commission. George Saunderson said he is comfortable if the applicant will work with the Conservation Commission to mitigate any problems. A roll vote was taken: George Saunderson – Yes; Jim Venne - Yes; Howard Pearl - Yes; Dave Powelson – Yes; Earl Tuson – Yes. Unanimous APPROVED.

#Z13-08, Variance for the construction of a commercial building and structures to be built in the steep slope district: Chairman Powelson compared the responses to those of Z13-07. Earl Tuson asked if the 1.02 acres they are proposing as steep slope impact on the plan is shown on the application. Jeff Lewis said it should be added. Mr.

Tuson reviewed the Zoning Ordinance and the plan with regard to steep slopes; he said he does not feel they need 1.02 acres. Chairman Powelson stated what the Board is approving is according to the plan which will be attached to the application for reference. On Point A-1, Jeff Lewis added after hearing steep slope definition he would say it is intended to protect hillsides with high rises. He said he does not believe that applies as they are not protecting a steep slope. Earl Tuson said the tiered nature fits in well with the grades they have shown. George Saunderson made a motion to approve #Z13-08; seconded by Howard Pearl. A roll vote was taken: George Saunderson - Yes; Jim Venne - Yes; Howard Pearl - Yes; Dave Powelson - Yes; Earl Tuson – Yes. Unanimous – APPROVED.

#Z13-11, Variance for the construction of a driveway off Route 106: Jeff Lewis went through the points of the application. Point #1: Howard Pearl said he would 100% agree. Point #3: Howard Pearl said Asby Road is not suitable for that kind of traffic; if they can get access on Route 106 that is the best option. Earl Tuson made a motion to approve #Z13-11; seconded by Jim


Venne. Howard Pearl said the best move for the town is onto Route 106, staying off Asby. Earl Tuson stated an abutter voiced his support for this plan at last month's meeting. A roll vote was taken: Earl Tuson -Yes; Dave Powelson - Yes; Howard Pearl -Yes; Jim Venne – Yes; George Saunderson – Yes. Unanimous – APPROVED.

Jeff Lewis said he feels they can withdraw the two special exceptions since the variances have been granted. On behalf of Greenpeace Nominee Trust and Dave Pritchard, Jeff Lewis formally asked to withdraw special exception #Z13-05 and special exception #Z13-04. He thanked the Board for their patience and willingness to work with the applicant.

ADJOURNMENT

Howard Pearl made a motion to adjourn the meeting at 8:55 p.m.; seconded by Jim Venne. All were in favor.
