Loudon Honors Its Service Men and Women, May 28

The American Legion hosted the Town of Loudon's annual Memorial Day Parade on May 28, 2018. The parade started around 9 a.m. and finished up around noontime. This year's parade was led by a military color guard commanded by Parade Marshall, Mike Moffett. Participants in the parade included the Town of Loudon Fire Department, Police Department, Police Department Rifle Team, Merrimack Valley High School Marching Band, Boy Scout and Cub Scout Troops from Loudon Troop 247, many walking veterans, and veteran's with disabilities riding in golf carts provided by the Loudon Country Club. Pastors Josh Owens and Pat Testerman from Faith Community Bible Church, Chaplain Alfred Page from American Legion Post 88, and Reverend Henry Frost held memorial observances at the bridge, library, and cemetery. The parade was well attended and the American Legion Post #88 had an Open House afterwards with food and refreshments as well as ice cream sandwiches and popsicles for the kids. The corporation shall not participate in, or intervene in any political campaign on behalf of any political party or candidate for public office, nor shall it sponsor or endorse any plan or proposition that does not facilitate or encourage informed citizen participation.

In other words, any article submitted must present *all sides* of an issue in a factual, unbiased manner so that the reader may form his/her own opinion based on the information presented. To paraphrase Eric Severard: “You should elucidate but not advocate.”

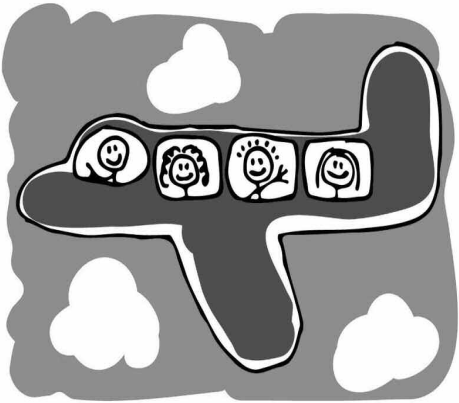

Fireworks: Leave Them to the Professionals

Fireworks are often used to mark special events and holidays. The best way to protect your family is not to use any fireworks at home. Be safe. If you want to see fireworks, attend a public show and leave the lighting to the professionals. Keep a close eye on children at events where fireworks are used. Don't allow them to pick up pieces of fireworks after an event. Some may still be ignited or hot and could cause an injury or a burn. Don't bring your pets to a fireworks display. Animals have sensitive ears and can be very frightened or stressed by the Fourth of July and other big celebrations. Fireworks including sparklers cause thousands of burns and eye injuries each year across the country.

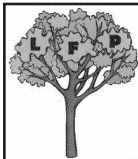
Water Safety Tips

Swimming is the most popular summer activity. One of the best things you can do to help your family stay safe is to enroll in age appropriate swim lessons. Swim lessons help to set the stage for a lifetime of water safety by equipping you with the knowledge and skills needed to help you and your family swim safely and with confidence.

- Swim in designated areas supervised by lifeguards.
- Always swim with a buddy; do not allow anyone to swim alone.
- Never leave a young child unattended near water. Do not trust a child's life to another child. Teach children to always ask permission to go near water.
- Set limits based on each person's swimming ability.
- Test the water temperature before you get in. Jumping into cold water can shock your body and elevate your heart rate and blood pressure.
- Enter the water feet first. Serious injuries can occur from diving head first into unknown water and hitting the bottom. Enter headfirst only when the area is clearly marked for diving and has no obstructions.
- Avoid alcohol. It impairs your judgement, balance, and coordination. Avoid it when swimming and supervising children.
- If a child is missing always check the pool or lake first. Every second counts in preventing an accidental drowning.
- Wear a life jacket when boating. Young and inexperienced swimmers may need a life jacket when swimming.
- Have a phone handy. The ability to call 911 quickly in an emergency could be a lifesaver.

Heatstroke – Never Leave Children or Pets Alone in a Car

Babies and young children can sometimes sleep so peacefully that we forget they are there. It can also be tempting to leave a baby alone in a car while quickly running into a store. The problem is that leaving a child alone in a car can lead to serious injury or death from heatstroke. Young children are more at risk as their bodies heat up 3 to 5 times faster than an adult. Never leave your child alone in a car, not even for a minute. If you see a child alone in a car dial 911. Your call could save a life. ■

To help make sure "hitchhiking" plants and animals do not enter our waters, The Clough Pond Association sponsors Lake Hosts who are stationed at the boat ramp to offer courtesy boat inspections. These inspections help prevent the introduction and spread of aquatic invasive species and animals from water body to water body. Once established, these invasive species and animals cannot be eradicated, therefore the education our Lakes Hosts provide is invaluable!

"Wheelabrator is a Concord-based energy-from-waste facility that provides dependable, environmentally safe disposal of up to 575 tons per day of post-recycled waste from homes and businesses in more than two dozen communities as a local fuel to generate as much as 14 MW of clean, renewable electricity for sale to the local community." From www.wtienergy.com/Concord

Loudon is one of the towns that send its post-recycled waste to Wheelabrator. On June 7 they had an open house, which three members of the Recycling Committee attended. We were impressed with the scope of the facility, as well as the professionalism of the staff and the cleanliness of the facility.

It is encouraging to see the trash that cannot be recycled is being used to provide fuel for our local electricity companies. With the shrinking markets for plastics and mixed paper, this company provides a viable alternative to recycling. The last shipment of mixed paper sent out by the Transfer Station cost \$76.52/ton to be recycled, while the current tipping fee for Wheelabrator is \$67/ton.

There is still a market for newspapers with inserts and good office paper. Are you willing to separate these out so that we can take advantage of the cost savings? Or does it make sense to start putting our mixed paper in the trash hopper? What's Cookin'? Best Barbecue

Barbecue Steak Teriyaki Skewers

Soak 16 wooden skewers in water and set aside while preparing meat.

Make Glaze:

- 1 cup Soy sauce
- ½ cup Brown Sugar
- 2 Tbls. Honey
- 1 Tbls. Mirin or rice vinegar
- 1 Tbls. Mince Garlic
- 1 Tbls cornstarch mixed with ¼ cup water

Put all ingredients, except cornstarch and water, into a sauce pan over medium heat; cook until hot and sugar is melted. Stir in cornstarch and water mixture until thickened. Remove from heat and cool.

Cut flank steak into long strips and thread long way onto skewers. Baste with sauce continuously while grilling. Grill until done to your liking.

Barbecued Desserts

Large sheet of foil for each serving.

Slice banana in half long way and put on the foil.

Chocolate chips

Mini marshmallows

Nuts if desired

Slice banana leaving skin on; fill center with chips, mini marshmallows, and nuts. Wrap foil to make a packet. Put on the grill for 5–7 minutes until toppings are melted. Open packet and top with ice cream if desired.

You can make a similar dessert using a sugar ice cream cone. Fill cone with chips, marshmallows, and nuts. Wrap with foil and grill the same as above.

Foil Grilled Squash

- 1 Tbs. butter
- 2 sliced summer squash and
- 2 sliced zucchini squash
- ½ onion chopped
- Salt & pepper to taste
- 1 Tbls. Parmesan cheese grated
- 1 Tsp. Basil

Cut large piece of heavy duty foil big enough to make a packet to wrap squash. Put on grill 12–15 minutes; turn ½ way thru cooking. Other additions could include sliced tomatoes or eggplant.

Grilled Bacon Chicken Rollups

- 10 Thin sliced chicken breast Cutlets
- 5 Jalapenos sliced in half and seeded
- 4 oz. Cream cheese softened
- 1 Cup shredded cheddar cheese
- 20 slices of bacon
- 1 Cup of your favorite Barbeque sauce

Pound each chicken cutlet thin between two pieces of parchment paper or plastic wrap. Season with salt and pepper. Rinse jalapenos to get rid of all seeds and dry. Mix cream cheese and cheddar cheese until well blended. Fill each ½ Jalapeno with cheese and put cut side down at one end of the chicken cutlet. Roll chicken around jalapeno. Wrap each chicken rollup with bacon. Tuck ends of bacon in so they stay wrapped. Put on 350 degree grill for 25 minutes turning every 5 minutes. Baste with barbeque sauce. Test chicken to 165 degrees.

Grilled Corn on the Cob

Heat grill to high heat. Peel back corn husks without removing and remove silk. Brush with butter then close up husks over corn. Wrap each ear in foil and grill 30 minutes turning occasionally. Unwrap and pull husk off to serve.

Grilled Salmon Packets

- 1 Large Salmon Fillet cut in serving pieces
- 2 lemons, one juiced, one thinly sliced
- Dill sprigs
- 1 Tbs. Butter
- Salt & Pepper to taste.

Cut large piece of heavy duty foil large enough to lay all salmon out on a single layer and cover and seal.

Start with ½ the lemon slices on the foil then dill. Top with salmon.

Top with the rest of the dill and lemon slices. Put lemon juice and butter on top and seal packet. Cook on Medium grill for 15 minutes turning ½ way thru cooking time.

Hawaiian Chicken Kabobs

- 1¾ lbs. skinless boneless chicken breast, cut in 1¼" cubes
- 1 large red onion, cut in 1¼" cubes
- 1½ large green peppers, cut in 1¼" cubes
- 3 Cups Fresh Pineapple, cut in 1¼" cubes

SAUCE

- 1/3 Cup Ketchup
- 1/3 Cup Brown Sugar
- ¼ Cup Pineapple Juice
- 2 Tbls. Olive oil
- 1½ Tbls. Rice Vinegar
- 4 Cloves Minced Garlic
- ½ Tsp Sesame Oil

Mix all ingredients together. Reserve ½ cup in container in refrigerator. In large Zip lock bag put all chicken and rest of the marinade, refrigerate for at least 1 hour. In another zip lock bag add vegetables and 2 Tbls. Olive oil toss to coat. If using wooden skewer soak in water for 1 hour plan on 2 skewers for each kabob so items will not spin when turned. Prepare kabobs onto 2 wooden skewers running parallel. Cook over 400 degree grill, brushing with marinade from refrigerator on all sides turning to cook all sides. Chicken should cook to 165 degrees. ■

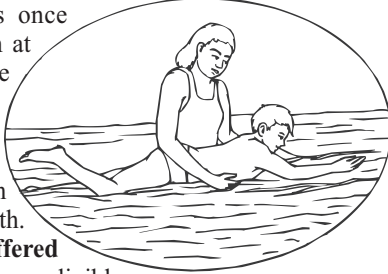

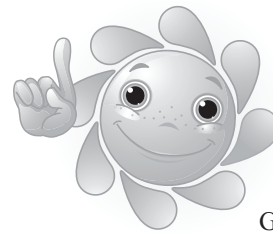


LOUDON FUN RUNS

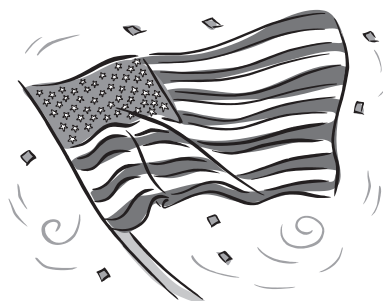

News From Richard Brown House

June has been another busy month with work to do indoors and outdoors! Manager Lucie and some residents planted vegetables, herbs and flowers in the raised beds and in flower beds around the grounds and hoped for both rain and sunshine. Maintenance of the grounds outside becomes hot dusty work for Rick, our maintenance man, during these summer months. Inside the building, air conditioners were needed early this year, especially on the second floor. We have also been reminded that falls can happen in any season, and that with age comes vulnerability to fractures.

One of our now regular presenters, Jennifer Pickard from Pittsfield Riteaid, gave a fun session on Ticks, Allergies and Skin care. Among the interesting tid-bits we learned was that pollen is most prevalent in the morning, so windows should be closed at night and air cooling or fans used if one suffers from allergy symptoms. Also that it is best to shower at night in order to wash off all possible allergens, dust mites, animal dander and so on rather than take it all to bed with you!

It is hoped that some residents will be willing to participate in the Loudon Historical Society Oral History project, which is part of the process preparing for the town's 250th anniversary in 2023. To that end, Andrew Parella, member of LHS, came to visit and explained something of the project. During that discussion it emerged that staff and residents would like to know more about Loudon citizen, Richard Brown, for whom the housing facility is named. If anyone knew Richard Brown or has an idea how we might find out more about him, please do be in touch with Lois.

The greater Concord AARP has reached out to us this year and 3 volunteers came to tell us more. One of them, Carol, told us that AARP membership world-wide is 38 million, and in New Hampshire, something like 230,000. Membership costs \$16.

Their office in Concord is above Gibson's Bookstore. We hope they will return for more information and discussion about the many aspects of aging in this state in particular.

Alyssa Lemmerman from the UNH Cooperative Extension has provided a whole series of enjoyable and hands-on sessions about senior health and nutrition this year. This month's class was about All Star Senior Snacks and the value of fiber and whole grains in our diets. Residents got to bake and sample breakfast cookies.

We are always grateful for donations and volunteers. One couple in Canterbury, Mr and Mrs Poitras, donated some exercise equipment. It has been very useful, not just for residents but also the visiting physiotherapists from the Concord Regional Visiting Nurses Association who have borrowed it for follow up post hospitalizations. Other possibilities for volunteering include leading a book club, or a chair-yoga type exercise group. Volunteering is not always an easy 'job' and requires commitment with flexibility and a willingness to share one's personality too. It can be immensely rewarding at the same time.

We have our decorations up for July 4! The gazebo is being stained a lovely cherry color and we have Home Depot's The Solutions band returning on July 5 at 6:00 pm in the evening if anyone local wants to pop in to share the music. The raised beds are filling with veggies, herbs and flowers which should make for a real bounty later in the summer. If any Loudon resident is interested in gardening issues, we have UNH Master Gardeners coming to talk about "Pest Control" on August 1 and 'Putting the Garden to Bed' on September 13. Do call 798 3190 if interested in attending and ask for either manager Lucie Bilodeau or service coordinator, Lois Scribner. ■

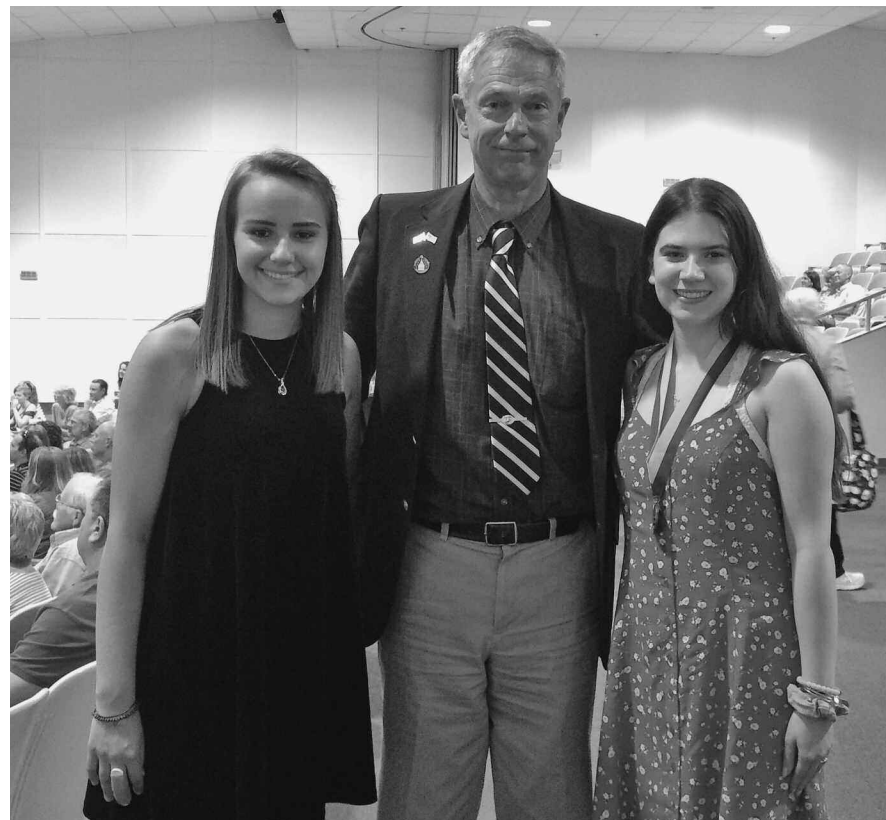

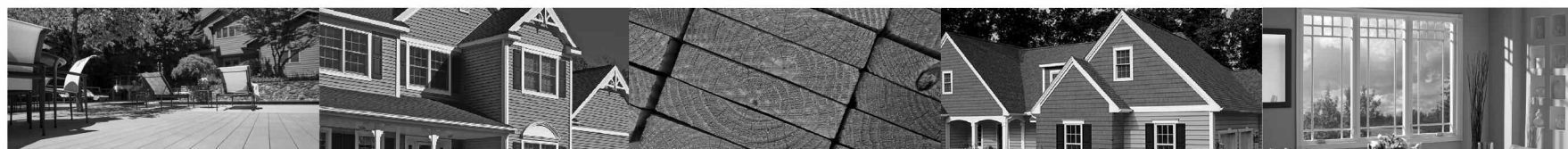

2017 Testing Shows No Evidence of CWD in NH

New Hampshire's white-tailed deer population once again showed no evidence of chronic wasting disease (CWD), based on monitoring data gathered during the 2017 hunting season.

The NH Fish and Game Department is asking hunters to do their part in the effort to keep the state CWD-free by not using natural urine-based deer lures and following state restrictions on importing carcasses from CWD-positive jurisdictions.

Chronic wasting disease is a neurological disorder that is always fatal to white-tailed deer, moose, mule deer, elk, and other exotic cervids (members of deer family). Currently it is not believed that CWD is transmissible to humans; however, hunters are still advised not to consume animals that may have CWD.

Deer Biologist Dan Bergeron recently received results from a federally certified veterinary diagnostic laboratory that indicate that all the deer tissue samples taken during the 2017 New Hampshire fall hunting season tested negative for CWD. In 2017, a total of 444 tissue samples from hunter-killed deer were tested by Fish and Game, with significant support from the U.S. Department of Agriculture Wildlife Services in Concord. New Hampshire's monitoring program is part of a nationwide effort to stop the spread of CWD. Since the monitoring program began in 2002, some 6,261 deer have been tested in New Hampshire.

Don't Use Urine-Based Lures — Here's Why

"While it is good news that New Hampshire remains CWD-free, we are asking hunters to help our herd by not using natural urine-based deer lures when hunting, because these products can potentially spread CWD," said Bergeron. Fish and Game recommends that hunters instead choose from among the many effective synthetic lures available on the market today.

The heart of the problem is that CWD is transmitted by an abnormal protein, also known as a prion. These abnormal proteins are very stable and may persist in the environment for several years, posing a risk to animals that come into contact with them. While most hunters use small amounts of these lures, continued application can have cumulative effects over time.

Studies have shown these prions are found in nervous system tissue, lymph nodes, saliva, urine, and feces, among other places. Urine for natural lures is collected from captive deer facilities outside of New Hampshire, many of which are located in states where CWD is present. In many cases, urine is collected from animals held in pens over grates which collect a mixture of urine, feces and saliva; the liquid portion is then strained out.

"Deer urine is not a regulated industry or product, and these lures do not undergo any treatment that might inactivate or kill disease-causing agents," said Bergeron. "Also, commercial lures are not tested for the presence of CWD prions."

Because of these risk factors, Fish and Game strongly discourages the use of natural urine-based deer lures while hunting. Several states and Canadian provinces have already banned the use and possession of natural urine-based lures. Further, evidence suggests lures are not as effective as marketing campaigns would make hunters believe. A survey conducted by the Pennsylvania Game Commission found that hunters who used urine lures were no more successful in harvesting a deer than hunters who did not. A study from Austin State University found urine lures were no more effective at attracting deer than other non-hunting scents. The researchers put trail cameras on "mock deer scrapes" and monitored visitations by deer. They found no difference in the

number of bucks that visited scrapes treated with urine lures versus those treated with human urine or new car scent. They concluded that the scrape was a visual attractant and the scent was merely a curiosity factor for the deer.

CWD Spreading Eastward

Chronic wasting disease was first identified in 1978 and remained isolated to Colorado, Wyoming, and Nebraska for about a decade. Since then, CWD has been found as far east as New York, Pennsylvania, Virginia, and West Virginia, bringing the disease far closer to New Hampshire's borders. To date, CWD has been detected in wild or captive deer in a total of 27 states and provinces. See a list and map of infected areas at www.wildnh.com/wildlife/cwd/.

Hunter-Killed Carcass Import Restrictions

In addition to monitoring and surveillance efforts, tight restrictions are in place regarding the transport of potentially infected animals, carcasses, or tissues.

Hunters who make hunting trips to CWD-positive jurisdictions are reminded that they must follow the mandatory regulations on bringing home deer, elk, or moose carcasses from CWD-positive jurisdictions to help keep New Hampshire CWD-free. You may legally bring back ONLY deboned meat, antlers, upper canine teeth, hides or capes with no part of the head attached, and finished taxidermy mounts. Antlers attached to skull caps or canine teeth must have all soft tissue removed.

In 2015, four of the samples tested in New Hampshire were taken from deer that were illegally brought into New Hampshire from a CWD-positive state. These deer were confiscated by law enforcement, and the individuals who brought them in were cited for a violation.

Bringing Home Deer from New York State

In light of New York State's extensive sampling efforts, with no additional positive deer found since 2005, and its decision to decommission their CWD Containment Area, New Hampshire Fish and Game officials felt that there was minimal remaining risk that CWD was still present and now permits importation of whole deer from New York. However, regulations in MA and VT still prohibit the importation of deer carcasses from NY and these regulations include the transport of NY-killed deer carcasses through these states. NH hunters are warned that simply crossing these states with a deer carcass from NY remains a violation and could result in legal prosecution. As a consequence, New Hampshire Fish and Game recommends that hunters continue the past practice of deboning NY deer. ■

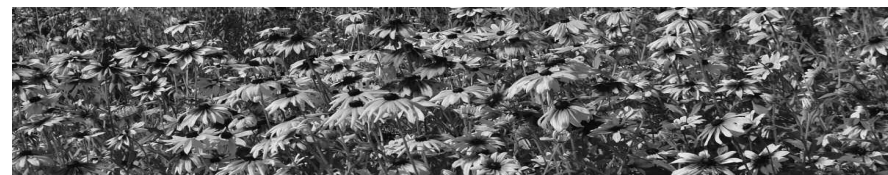
JEREMY JAMES CHESLEY

Selectman Miller said they'd like to get two cuts out of it. Julie said it might be possible to get two cuts if it is done right at August 1st, she said Alan Barton has been doing it for years and they always do it later. Julie explained that the bobolinks are nesting in the field now; they are later nesters and in order for them to fledge July 15th would be the earliest. Selectman Prescott said they've spoken to some farmers; they want two cuts and if they have to wait until August 1st they won't get it. Selectman Prescott said John Storrs is in the audience and has been asked to speak about the cutting process. Selectman Prescott said the way it has been hayed the last few years there isn't any value in the hay. Julie said the earliest is July 15th; she explained that one reason they bought that property was for the bobolinks. Selectman Prescott asked if part of the field can be hayed. She said no because they are throughout the field; she explained that in her entire career with Fish and Game she has never seen a field so full of bobolinks. Selectman Miller said he understands that they didn't purchase the property for anything other than conservation. He said he also understands it from a farming view; the field needs to be maintained as a field. John Storrs said the field needs to be fertilized; it hasn't been taken care of. Julie agreed to benefit both the bobolink and farmer they can go with July 15th for the first cut. The Board will put the bid out for the haying.

The Board met with Road Agent Lance Houle.

Mr. Houle gave the board three copies of information from the UNH Technology Transfer Center. They are holding a Road Maintenance 101 workshop for Town Administrators, Managers and elected officials.

Mr. Houle submitted a list of roads to shim. Chairman Fiske asked if the list is by priority. Mr. Houle said it is not. He explained that the amount is a guestimate. The Board will review the list.

Mr. Houle said Pike will grind Pleasant Street the 8th or 9th of next month.

Mr. Houle said they are trying to get the roads graded.

Mr. Houle said they widened a section of Kenney road.

Selectman Prescott asked if Berry Road is all set. Mr. Houle said they've graded it. He said they dropped the road near the Touzin driveway so they can get in and out of their driveway better. Mr. Houle said he spoke to George Page who asked about a culvert at the end of the road. Mr. Houle said they dug out the culvert last year and they did it again.

Selectman Prescott asked about the sign at the Villages. He asked why Mr. Houle would put a sign on private property. Mr. Houle said he hasn't put it up, he was asked to put it up. Mr. Houle said he has a sign that was no cost to the town that he could put up; he asked for direction from the Board. Chairman Fiske asked if there was an agreement regarding the cul-de-sac and plowing. Mr. Houle said they do use it and have since before his time. Chairman Fiske said that due to the commitment that was made months ago Mr. Houle can give the sign to the gentlemen but he doesn't want Mr. Houle to install it. Selectmen Miller and Prescott agreed that the sign should be provided but not installed.

Chairman Fiske recognized Jay and Jim St. Jean Auctioneers.

Jay handed packets to the Board with a proposal for an auction of tax deeded properties. He explained that they looked at the four properties that he received information about. He said the properties will make for a nice auction. Jay suggested that instead of a caravan from property to property they hold the auction in the meeting room with a power point presentation; he would suggest if not that then do all of them at the Old Shaker Road location. Chairman Fiske asked about mortgages on the properties. Jay suggested talking to the town attorney. The Board will talk to the town attorney and get back to the St. Jean's.

Chairman Fiske recognized David Moody and Dan Plourde from the audience.

Mr. Moody said he heard there is a controversy over a property line and how close he can dig. He explained that when he bought the property he made an agreement with the town

to dig to the property line and the town takes their material from there on out so the town can use it for their roads. Chairman Fiske asked if that was a written agreement. Mr. Moody said there is an easement in the deed. Chairman Fiske said Lance contacted Bob Cole for his expertise, he and Selectman Prescott visited the lot. Selectman Prescott said he went there with Web Stout because the Board decided that they should know where that line is. He explained that they would like to run that line and put in stakes. Chairman Fiske asked if this is something that Mary Pinkham-Langer would be in agreement with. Mr. Moody said yes. Selectman Prescott said they will get the stakes put in. Selectman Miller said with this new Board they just wanted to be sure they are doing what is best and right for the town. He said he appreciates what Mr. Moody is doing.

The Board received one cemetery bid for review from Saints Lawn Care for \$8,400. Chairman Fiske said he understood that the Mount Hope and Moore Cemeteries were going to be removed from the list. Selectman Prescott agreed. Selectman Prescott said that he, Mr. Banks, the prison workers, Tom McNeil, and Larry Lebrun fixed a lot of stones in the Mount Hope and Moore Cemeteries and as of today they are ready for Memorial Day. Selectman Prescott suggested that the highway department hire someone for the summer. He said that person would get paid out of the cemetery money and would supervise the prisoners and mow the cemetery. Selectman Prescott said he could also go around to the small cemeteries, cut brush and do whatever needs to be done on a rotating basis. Selectman Miller clarified that this would be a part-time employee under the highway department for just the cemeteries. Chairman Fiske asked how much time it would take. Selectman Prescott said he doesn't know. The Board agreed that they will think about this option and did not accept the bid that was submitted.

The Board began their review of weekly correspondence.

The Board received a letter from George Sansoucy regarding the Fairpoint test cases trial.

The Board received the ESMI Self-report for March and April 2018.

The Board received the ESMI 1st quarter 2018 Host Community Fee.

The Board received a letter from the NH Liquor Commission regarding a retail tobacco liquor license.

The Board received a copy of the Merrimack Valley Trail Riders approval from Fish and Game.

The Board received a letter from Police Standards regarding Chief Burgess' firearms recertification.

The Board received two emails from B. Gordon regarding Berry Road.

The Board received an email from M. Harris regarding NHMS.

The Board received a copy of Military Orders regarding A. Strout.

The Board received time off requests regarding Beck, Strout and Goley.

The Board received an Eversource tree-planting poster.

Chairman Fiske explained that they received a request from Deputy Lake for payment in lieu of time-off. He said he would like to hear from Chief Wright about it. Selectman Prescott said he isn't in favor of approving it, he thinks employees should be taking time off, they've earned it. He said he might be in favor of paying half of it. Selectman Miller said they did it for another employee and started a precedence that needs to stop. Selectman Prescott said it affects budgets.

Chairman Fiske said that last night the Fire Department, Police Department, Fish and Game and residents assisted in a search for a 13-year old. He said fortunately there was a positive outcome. Chairman Fiske said Janice Morin was instrumental on the Police Facebook page keeping people abreast of what was going on and adding information regarding the search which was very helpful. He thanked everyone for a job well done. Selectmen Miller and Prescott agreed. Selectman Miller said his wife saw it on facebook and they started seeing people communicating on facebook, probably on smartphones, while they were searching.

Selectman Miller said Fran Nash was a town employee for quite some time, it's tragic news. He said they learned the news last evening after they started the prayer vigil at the library. Selectman Miller suggested that a section of the library be dedicated to her by way of a plaque. Chairman Fiske agreed saying they should get input from the Library Trustees. Selectman Prescott agreed.

Selectman Miller made a motion to authorize Chairman Fiske to sign on behalf of the Board a request for transfer of accrual time. Seconded by Selectman Prescott. All in favor. Motion carried.

Chairman Fiske read a reminder that the Zoning Board is meeting Thursday, May 24th at 7 p.m.

Selectman Prescott moved to adjourn at 7:49 p.m. Seconded by Selectman Miller. All in favor. Motion carried.

Selectmen's Meeting Minutes — May 29, 2018

Present:

Chairman Fiske, Selectman Miller and Selectman Prescott.

Chairman Fiske called the meeting to order at 6:00 p.m.

Selectman Prescott moved to approve the Selectmen's Meeting Minutes of Tuesday, May 22, 2018 as written. Seconded by Selectman Miller. All in favor. Motion carried.

The Board met with Police Chief Kris Burgess

Chief Burgess submitted an annual evaluation for Tom Hebert.

Chief Burgess said he has officers scheduled for the Cystic Fibrosis run on June 9th and 10th.

Chief Burgess said they have five officer's that are due for bullet proof vests. He explained that he bought three out this budget and will purchase two from the new budget.

Chief Burgess explained that they had an employee that was admitted into the hospital for the weekend. He said that due to the fact that the employee is still on probation there is no sick time available. He asked if he could give her 37 hours of his sick time so that employee will receive full paychecks. Selectman Miller said he doesn't have a problem with it as long as he is aware that he is giving away his time. Chief Burgess said he is and filled out the form accordingly. Chairman Fiske and Selectman Prescott said they also don't have a problem with it.

Chief Burgess said it looks like they might have to purchase a new server. He hasn't gotten a definite answer yet. Chief Burgess said he has the money in his budget to purchase it. He will let the Board know when he finds out if in fact he needs to purchase it.

Chief Burgess submitted a quote from Arcomm for cameras at the station. He said he has the money in his budget. Chairman Fiske asked if these will go through Merrimack County. Chief Burgess explained that he would like to do that it's a matter of whether their IP addresses and Merrimack County's are compatible; he believes it is possible. Selectman Miller asked the Chief to contact the Sheriff in the next week to see if it's possible. Janice Morin asked if they will be able to view them at the PD as well. Chief Burgess said yes. Selectman Miller said they should work really well and it's an extra set of eyes.

Chief Burgess said he received a right to know request. He said they have reached out to NHMA for guidance as to what can be released. Chief Burgess said he might have to contact the town attorney.

Chief Burgess said the Memorial Day parade was a success. Selectman Miller thanked Chief Burgess and his crew for doing it.

The Board met with Fire Chief Rick Wright.

Chief Wright said he received a complaint from a resident on E. Cooper Street about the

construction noises at the Dollar General. He said he was told that they are working 8 a.m.–8 p.m. seven days a week. Chairman Fiske asked if Chief Wright has checked with the Planning Board. Chief Wright said he looked through the minutes but didn't see anything about when they can work. Chairman Fiske suggested he check with the Planning Board Chairman to see if there were any building requirements. Selectman Prescott said that Sunday isn't a general workday and they should convey that it isn't appropriate. Selectman Miller said they need to be a good neighbor. Chief Wright will follow up on this.

Chief Wright said he spoke with the Homeland Security Director Perry Plumber last week. He gave Chief Wright a verbal approval for the Emergency Operations Center grant for the upgrade to Station 2 they have been working on for a long time. He explained that they still have to have it reviewed by the Governor and Council but he's been given the verbal approval and expects the formal approval in July. Chief Wright said there is a long list of things that at the station that needs to be updated to make it a proper EOC. He said some of the big things include new two-way radios, antenna's, an HVAC upgrade, the electrical service from the street, new generator, security and access to the building, new office equipment and furniture. Chief Wright said this is a 50/50 grant. They are using what the fire and police get paid for races as the towns 50 percent. Chief Wright said the grant is more than \$200,000.

Chief Wright asked about the request for pay in lieu of time off for Deputy Lake that is supposed to be used by June 30th. Selectman Prescott said he thinks he should use half the time and get paid for half the time. Chief Wright said it's a lot of time to take off in a month which impacts them because they have to hire people to cover him. Selectman Prescott said he would like to see people use their time, they have it for a reason. Selectman Miller asked if he has been taking time off. Chief Wright said about a week per year; but he earns more than that. The Board all agreed with the Deputy getting paid for half and using half.

Selectman Miller thanked Chief Wright and his staff for the equipment and for marching in the Memorial Day parade.

The Board met with Road Agent Lance Houle.

Mr. Houle submitted a contract from Pike for Pleasant Street. He said they will be starting July 8–9th. Selectman Miller asked if white lines are going to be painted on the road. Mr. Houle said that's up to the Selectmen. Selectman Prescott said he provided a link to a website that contains the Manual for Uniform Traffic Control Devices. He explained that the manual outlines how and what should be painted. Mr. Houle said he has those books.

Chairman Fiske asked what they say about the white lines. Mr. Houle said he thinks it is a good marker for the public. Chairman Fiske asked if there is a difference between 20 and 22 feet. Mr. Houle said he doesn't know. Selectman Prescott said the book explains that; it is a standard that must be followed. Chairman Fiske said the road should have a double yellow and a white line on each side. Selectman Prescott asked if this contract is for the amount that was originally on the bid. Mr. Houle said the extra is for the compaction test that was asked for. Selectman Prescott asked if they should take a week to review this. Mr. Houle said that will put him back, the longer they take the further they will be out on the schedule. Chairman Fiske said they accepted the bid so he is good with this. *Selectman Miller made a motion to accept the contract from Pike Industries in the amount of \$293,881 for the purpose of reclaiming and repaving Pleasant Street. Seconded by Selectman Prescott. All in favor. Motion carried.*

Mr. Houle said the market in recycling has dropped to nothing, China is not purchasing. He said it is costing the town money to recycle mixed paper; it used to be revenue now it is an expense. Mr. Houle showed the Board paperwork that shows how the price has dropped for the mixed paper and how it is costing the town. Chairman Fiske asked if they are still picking up at Penny Press. Dustin Bowles said they are picking up about seven pallets a month. Mr. Houle said they also pick up quite a bit of cardboard from there. Mr. Bowles said they used to deliver it to the transfer station but they got rid of the truck so the town agreed to pick up their paper and cardboard. Chairman Fiske asked how the recycling committee feels about not recycling the paper. Mr. Bowles said they are opposed to it because they want to recycle. He said he spoke to NRRRA today; some towns are going to try baling their paper and some are not recycling it until the market comes back up. Selectman Miller asked how much it costs to dump it. Mr. Bowles said \$67+/- per ton. Mr. Bowles said he doesn't believe they have enough newspaper and office paper to make it worth baling. Mr. Houle said he isn't against recycling and if the price comes up they can start recycling it again. Mr. Bowles suggested that they continue recycling it for another month. Chairman Fiske said if it's costing the town money maybe they shouldn't. Selectman Miller said it's worth checking out other options for the paper. Selectman Prescott agreed. Mr. Houle agreed to another month to see if there is another market out there. He said this isn't something that just happened; it has been coming for months. Selectman Prescott said if it's been months they should have been made aware of it. Chairman Fiske suggested that the recycling committee look into options for recycling it.

Chairman Fiske recognized the Recreation Committee.

Laurie Jacquith explained that NH Motor Speedway read in the minutes that the rec committee was going to be working on the rec field and asked how they might help. She said they helped with the ballfield, the dugouts,

they repainted, weed whacked, fixed fencing, picked up trash, removed trees, etc. Ms. Jacquith submitted a display of pictures of the NHMS crew working. She said they also donated a couple of picnic tables. Alicia Grimaldi said a good amount of work done from the list they had submitted to the Board. She said they want to discuss more items from the list as well as a timeline for getting things done. Ms. Grimaldi said they want to work on the skate park and the Alex White mural and set a date for dedication of it but there are certain things that have to be done before they can do that. She said they are getting quotes for repairs to the concrete. She asked if work can be done on the shed/garage; door casing is rotted, siding is missing and there was some talk about installing a security camera. Chairman Fiske said there was some talk about having the prison crew work on it. Chief Burgess said the correction officer spoke to him about the building; they are aware of it and are more than willing to do the work. Mr. Houle said he has been working with them; they are staining the gazebo, they are going to do the siding, it has been bought and as soon as they have time they will do it. Mr. Houle said he has no idea about the size of the mural and if he is told they will work around it. Ms. Grimaldi said its great to know this. She explained that the mural will be the size of 4 4x8 sheets of plywood. Ms. Grimaldi asked about the security camera's. Chief Wright said they have Comcast Camera's at Station 2. Mr. Houle said that he has been working with Comcast since January to get cameras at the Transfer Station. Janice Morin suggested that maybe a camera could be added to the camera's that the police department is looking into. Chairman Fiske asked Chief Burgess to look into that. Ms. Grimaldi said the pickleball court lines will be painted within the next two weeks. She asked Mr. Houle about the small trees that are growing around the tennis courts; if they continue to grow they will mess with the courts. Mr. Houle said they will get them out of there. Ms. Grimaldi said the field closest to the Dows property there is a fiberglass bench that needs to be removed; it is splintering, not attached and dangerous. Ms. Grimaldi asked what can be done about the piles of old soccer nets. Mr. Houle said there are full size nets that weren't used last year but they are in good shape and shouldn't be disposed of. He said the smaller ones are used. Chairman Fiske said they will check with Breanne about the nets. Ms. Jacquith said there are what looks like used to be batting cages by the tennis and basketball courts but are not anymore. They would like to use that area for a new playground. She said it would be more visible for parents. Chairman Fiske said he'd like to go there and take a look at the area before making a decision. Ms. Jacquith asked if perhaps the poles can be used for a shade awning. Mr. Houle said as soon as they can they will be removing trees and thinning brush.

Chairman Fiske said that being 7 p.m. they will be meeting with the Recycling Committee, who have asked for a nonpublic session. Bar-

bara Burr asked Mr. Houle and Mr. Bowles to attend the meeting. Selectman Miller moved to go into nonpublic session per RSA 91-A: 3, II (c) at 7:09 PM.; seconded by Selectman Prescott. Roll call vote: Fiske – yes; Miller – yes; Prescott – yes. All in favor. Motion carries. Selectman Prescott moved to come out of non-public session at 7:38 PM; seconded by Selectman Miller. Roll call vote: Fiske – yes; Miller – yes; Prescott – yes. All in favor. Motion carried. Selectman Prescott said they discussed recycling.

Chairman Fiske recognized Julie Robinson, Chair of the Conservation Commission. Ms. Robinson said that she reviewed the bid request for the Chesley field; it should say it will not be hayed before July 15th. She explained that she did a survey of the Bobolinks so they have a control, they know what is in the field. She will do that survey this time again next year and if they find that there is an impact by the July 15th date they will have to revert to August 1st. Selectman Miller said so the bid will be for one year only. Ms. Robinson said it can be for five years but the parameter might change after the first year. Mr. Barton asked who decided on July 15th. Chairman Fiske said it was the Conservation Commission. He asked Mr. Barton if there is anyway there can be two cuttings if they can't start until August 1st. Mr. Barton said it would be pretty hard. Mike Martel said that question is pretty vague because it depends on whether you are making dry hay or haylage. Chairman Fiske confirmed that it could be done starting August 1st then. Mr. Martel said yes if you are set up to do two different types of hay. Ms. Robinson explained that the Conservation Commission purchased the property to protect the land as well as the wildlife. She said she doesn't have a problem with the haying but they need to do it and protect the wildlife. Mr. Martel asked if any field work can be before the birds get there. He explained that he looked at the field and to reestablish it he would brush hog it, fertilize and amend it. Ms. Robinson said the field should not be disturbed until July 15th. Chairman Fiske agreed that nothing can be done until July 15th. Mr. Barton said he would only get one cutting if it is moved to August 1st. Chairman Fiske suggested that the bid go out for one year now. Selectman Prescott asked how many bobolinks there are in the field. Ms. Robinson said they are polygamist so on three occasions she counted the males, which are up on the stem, and there were six or eight males which means there were many more nesting females. Ms. Robinson suggested that they do one year with the July 15th date, do the survey next year and then put the bid out next year for five years for either July 15th or August 1st depending on the survey. The Board agreed that the bid will go out for one year with the July 15th date.

Selectman Miller moved to go into non-public session per RSA 91-A: 3, II (c) at 7:55 PM.; seconded by Selectman Prescott. Roll call vote: Fiske – yes; Miller – yes; Prescott – yes. All in favor. Motion carries. Selectman Prescott moved to come out of non-public session at 8:04 PM; seconded by Selectman Miller. Roll call vote: Fiske – yes; Miller – yes; Prescott – yes. All in favor. Motion carries.

ried. A library employee's monument/memorial was discussed.

The Board received a letter from Jamie Stevens and asked Mr. Houle to read it. Mr. Houle said the road got built way up before his time with the town, he cut it back down at the driveway. Mr. Houle said he spoke to Tad Flagg who worked here at that time, he explained that the whole road was brought up, from the Concord line. He said it was mud so they brought in loads of gravel. Mr. Houle said he told Ms. Stevens that when there is a good rain he would sit out in front of her driveway to see how the rain runs into her yard. He explained that until then he made a little ditch to try and keep the water out of her yard. Mr. Houle said he can't cut the road without causing an issue with the driveway across the road. Chairman Fiske confirmed that Mr. Houle will look into at the next big rain. Mr. Prescott said the day he was there it was raining and running right down the driveway towards the deck.

Mr. Prescott asked about the light at the Historical Society. Mr. Houle said he changed the bulb but there are more problems and he is not an electrician.

Mr. Prescott asked if the sign has been delivered to the Villages. Mr. Houle said it has been.

Mr. Houle said he was told that he can't split up Holiday time. He said on Dustin's timesheet this week he had split time and he has no problem with it but he is being told that they can't split the hours. Selectmen's Meeting Minutes — June 5, 2018

Present:

Chairman Fiske, Selectman Miller and Selectman Prescott.

Chairman Fiske called the meeting to order at 5:01 p.m.

Selectman Miller moved to approve the Selectmen's Meeting Minutes of Tuesday, May 29, 2018 as written. Seconded by Selectman Prescott. All in favor. Motion carried.

Chairman Fiske explained that they were meeting with the scholarship committee to discuss the high school scholarship awards.

The Board met with Police Chief Kris Burgess, Phil Nadeau and Terry Hammond.

Chief Burgess explained that Mr. Nadeau and Mr. Hammond live on Lesmerises Road. Chief Burgess said they put together a petition; they would like the speed limit reduced from 35 to 25. Mr. Nadeau explained that the speed on the road has increased, on any given day vehicles go 45–50 miles per hour. He explained that 35 doesn't seem rational. Mr. Nadeau said there are two disabled people and a deaf person that live on the road. He said he has witnessed near accidents on the road. Mr. Nadeau said he realizes that lowering the speed limit won't solve anything, people won't suddenly go 10–15 miles per hour slowly, but it's a start and sends a message. He explained that this is consistent with the Masterplan that was written around 2000 that calls for roads to be a safe and pleasant way to move within Loudon. Mr. Nadeau said they will pay for the two signs to save a tax burden

on the town. Selectman Miller said in his opinion the road is far more narrow than other roads in town and the population on the road has increased. He said he has a problem understanding why Village Road which used to be a state highway has a 30 mile per hour speed limit but this secondary road has a speed limit of 35. Selectman Miller said if they lower it, it becomes an enforcement tool for the police department. He said that if dropped the police can start by giving out warnings and explain that the speed limit has dropped, he said it might discourage people from using it as a cut-off. Chairman Fiske said last year Chief Burgess and his people did a directed patrol. He said he would like to see data from the speed trailer. Mr. Hammond said when the survey was done last time it was in the winter. He explained that this time of the year there are a lot of walkers, bikers etc. Chairman Fiske said if they put the trailer up there for a week now during the busier time of the year; they will have statistics. Selectman Prescott said he agrees with what they are saying to a point, he doesn't think it should go down to 25. He said he also agrees with Chairman Fiske that there should be some statistics, let it run for a week, see when the speeders are coming through there and do somethings about it. Selectman Prescott said he CNHRPC does traffic counts. He suggested that this road be included in the count so they know how many cars are traveling the road as well as how fast they are going. Selectman Prescott said when he goes to the dump he travels Lesmerises Road, usually during the day and seldom sees any other traffic. He said he personally doesn't think the road is fit to be going 35. Mr. Hammond said there are 42 other people that agree that this road isn't safe. Selectman Prescott said he'd like to see the speed trailer out for a week. He said he's not opposed to lowering it but he would like to get the data first. Chief Burgess said the trailer will be ready to be put out in a couple of days. Mr. Nadeau asked what the process will be moving forward. Chairman Fiske said once they have the data, they will review it, make a decision and then notify them. Chief Burgess said in his opinion it isn't a speed problem; it's that they feel it isn't a 35 mile per hour road

when roads like North and South Village Road are 30. He said they also think the road is unsafe, it is narrow, with potholes, and a lot of people walk and bike on it.

Selectman Prescott moved to go into non-public session per RSA 91-A: 3, II (c) at 6:07 PM.; seconded by Selectman Miller. Roll call vote: Fiske – yes; Miller – yes; Prescott – yes. All in favor. Motion carried. Selectman Prescott moved to seal the minutes for five years; seconded by Selectman Miller. Roll call vote: Fiske – yes; Miller – yes; Prescott – yes. All in favor. Motion carried.

The Board met with Police Chief Kris Burgess.

Chief Burgess explained that he has a second quote for the cameras; it is slightly different from the quote he submitted last week this one includes the time for the company to go to go to Merrimack County Dispatch to set up the remote access. Chief Burgess said this quote does not include the camera to go on top of the building for the rec field. Janice Morin said she spoke to Glen today and someone will come out and see if the top of the building is the best place for the camera. Chief Burgess said he has enough money in his dispatch line to cover this. The Board agreed that Chief Burgess can sign the contract and move ahead with the cameras.

Chief Burgess said the NHMA attorney clarified their question about the right to know.

Chief Burgess said Monday Chief Burgess and Janice Morin will be attending a right to know class.

Planning Board Meeting Minutes — May 17, 2018

Meeting called to order at 7:00 p.m. by Tom Moore

Attendance:

Tom Moore, Henry Huntington, Bob Cole, Alternate Ex-Officio Stan Prescott, George Saunderson, John Storrs and alternate Dustin Bowles.

Sandra Simms from the Conservation Commission was present in the audience.

Chairman Moore appointed Dustin Bowles a voting member in replace of Alice Tuson.

Acceptance of Minutes:

April 19, 2018 Regular Meeting — Mr. Storrs made a motion to approve the minutes as written; seconded by Mr. Cole. Mr. Prescott abstained as he wasn't present at the April meeting, all in favor; Approved.

Discussion:

Joe Wicker came in to discuss a Subdivision on Shaker Road that is in both Canterbury and Loudon. Mr. Wicker explained the house that is currently on the property they are looking to subdivide off with the majority of the road frontage in Loudon but some in Canterbury. Mr. Wicker explained the land owner would like to build a home on the empty lot that will be created with the driveway in Canterbury but the home in Loudon. Mr. Prescott said as long as they follow the regulations set by the town this shouldn't be an issue.

Old Business:

Application #18-03 NHMS Site Plan, Map 51 Lot 19, C/I District — Naomi Paul and Tim Andrews from Nobis Engineering were present as was Matt Goslant V.P. of operations from NHMS. Mrs. Paul said they have come back this month to discuss a Site Plan for a flat track on property owned by NHMS. Mrs. Paul said they have added a red line indicating the boundary line as well as a yellow dash line to indicate the conservation area. Mr. Saunderson asked if they have re-notified the abutters. Mrs. Paul said they have notified all abutters to this parcel. Chairman Moore

said they had discussed the extended abutters list. Mrs. Paul said they opted to just notify the abutters to this parcel. Mrs. Paul wanted to clarify that this application was to construct a facility not an application for a specific event. Chairman Moore questioned if the property was in the C/I District or C/R District. Mrs. Paul said according to the Zoning Map it is in the C/I District but if you read in the Ordinance it says the C/R District blankets the NHMS property and technically it is in the C/R District but the Zoning Map doesn't state that. Mr. Saunderson said he believes this is Regional Impact. Mrs. Paul said she doesn't believe this is of Regional Impact. Mr. Saunderson said now that all the abutters have been notified it would be time to accept the application as complete and move forward with a public hearing or vote on Regional Impact. Mr. Goslant said this event will run in conjunction with events that are already held and will not add a noise and traffic. Mr. Goslant said they hold big events that require a traffic control plan for 15,000 people and this event will only be maybe 500 people. Chairman Moore questioned if the 500 people that will attend this event are the same people that would be going to the other event or is it bringing in additional people. Mr. Goslant said the number of participants they currently get is about 200 and almost no spectators. Mr. Goslant said he expects people to double up on both events so it shouldn't bring many additional people. Mr. Goslant also pointed out that at the last meeting he thought everyone agreed that they would test out one event and see how it goes for further approval. Mr. Huntington made a motion to accept the application as complete; seconded by Mr. Cole. All in favor; Accepted. Mr. Saunderson made a motion to seek Regional Impact; seconded by Mr. Huntington. A roll call vote was taken George Saunderson yes, Henry Huntington yes, Dustin Bowles no, John Storrs no, Bob Cole no; motion denied. Jim Snyder spoke

about Regional Impact and said that if there is any doubt about Regional Impact it must be declared. Mr. Snyder is the Chairman for the Canterbury Planning Board and explained how they deal with Regional Impact by saying if one member thinks it is cause for Regional Impact they will notify for Regional Impact. Mr. Harris said there is a common law of clean hands that states any person that comes before a court or judicial body must have clean hands and if they have unclean hands they have no right to go before the Board. Mr. Harris said there is a long-standing agreement with the Town and NHMS that there are no fireworks. Michael Harris spoke about NHMS lighting off fireworks and it has interrupted his family's sleep. Mr. Harris also spoke about NHMS not providing a calendar of muffled and unmuffled events. Chairman Moore said that NHMS has provided a calendar and if he would like to speak about the application he is welcome to. Mr. Harris said this is about unclean hands. Mrs. Paul went over the application that will be located behind the gas station. Mrs. Paul said the track will be pitched in so all the water will run into the middle. Mrs. Paul said this site will have its own access off of Gil Rogers Highway. Mr. Prescott questioned the site having grandstands. Mrs. Paul said there is no formal plan for seating at this time as they would like to see how the events go and if it is successful and they need seating they will come back with another application. Mr. Saunderson asked about the noise level. Mr. Goslant said they spoke about a decimal level of 85 at 50 feet he believes. Mr. Saunderson asked how many events they plan to hold this year. Mr. Goslant said anywhere from 1–12 events as they don't have anything formal planned. Mr. Saunderson questioned since this was the first year holding the events that they limit it to four. Mr. Goslant said they have six Loudon Road Racing Series events currently on the calendar and he would wish for a minimum of

six events. Mr. Prescott questioned the map if it was showing a rock wall. Mrs. Paul said there is a rock wall. Mr. Prescott questioned parking and where cars enter. Mr. Goslant explained the Site Plan location of spectators and parking. Mr. Prescott questioned the size of the land that will be used. Mrs. Paul said the area they will disturb is four acres. Mr. Bowles asked if they will have emergency crew lined up for this. Mr. Goslant said absolutely they will and they will abide by the same standards as any event held on NHMS property. Chairman Moore asked for any abutters that would like to speak and none were present. Dennis Jakubowski questioned the decimal level and if any limit will be set. Mr. Goslant said they are held to a standard of 98 decimals at 50 feet. Mr. Goslant said they would try their best to reduce this to 85 decimals at 50 feet. Linda Cote questioned if this property is restricted by the 1989 agreement. Mr. Goslant said this property is not subject to the 1989 agreement. Mrs. Cote questioned why the Town would allow them to build a whole new race track that has no time limits or restrictions. Mrs. Cote said that NHMS often says they are going to do one thing and then does something entirely else. Mrs. Cote spoke about a recent incident where she made a noise complaint. Mrs. Cote said that NHMS has security that doesn't follow through. Mrs. Cote has evidence she said there was drifting at the property from 4:00–7:00 p.m. Mrs. Cote said that NHMS has to be held accountable. Mr. Harris said they don't have clean hands. Hillary Nelson a Canterbury Resident said if there is any night racing that will take place on this then it is definitely Regional Impact. Mrs. Nelson said she would like to at least see restrictions on times of racing. Chairman Moore closed the meeting to the public and opened it to the Board only. Mr. Saunderson said if they are going to allow this he thinks they should limit the number of events as well

as give a temporary approval for only the summer so they can evaluate next year. Mr. Saunderson said he isn't sure about a sound study for this event on the first year but believes a decimal level should be set and possibly look into a sound study in the future. Chairman Moore questioned what type of studies have been done and how confident are they that they can get the decimal reading down. Mr. Goslant said with the height of the barriers and mufflers he believes they will not go above the 98 decimals at 50 feet. Mr. Goslant said during an event they would be willing to test the sound on different areas. Mr. Saunderson said this track won't be in a stadium and have no sound barriers. Mr. Goslant said they could put up billboards. Mr. Prescott questioned the time of the race. Mr. Goslant said they will hold the same standards as they have currently which has a start time of 8:00 a.m. and an end time of 7:00 p.m. There were several waiver requests Chairman Moore read. Mr. Green said he can show the floodplain lines on the map that are indicated by FEMA. Chairman Moore asked if any lighting would be on the outside of the building. Mr. Green said there would only be indoor lighting. Mr. Bowles said there should be a waiver request for the lighting. Mr. Green said if there is no lighting he shouldn't have to do a waiver. Mr. Green said in the past applicants have submitted a waiver for no separate lighting plan and only to show it on the site plan and in this case he isn't doing any lighting. Application #Z18-07 James Howell — Special Exception — Wetlands Setback, Map 2 Lot 8-1, RR District

James Howell approached the Board to discuss his application. Abutter Richard Bittle was present. Mr. Howell said the current future placement of the house is set back 780 feet with a shared driveway and he would like to have the house built at the front of the property. Mr. Howell said that Dennis & Matt Moore have told him that he has enough room in the front to build the house. Mr. Tuson said he would need a special exception by the plan that was approved for the driveway to cross the side setback. Mr. Saunderson asked for the elevation map. Mr. Howell said he can get that. Mr. Pitman asked if a Site Walk was done for the Subdivision approval. Mr. Saunderson said they did not do a Site Walk and they should invite the Planning Board. Mr. Bittle said he has concerns about where the house will be built due to water issues they currently have. Chairman Lizotte said he is welcome to come to the Site Walk. Mrs. Bittle said at what meeting will they discuss the placement of house. Mr. Merrill said they are discussing house and driveway location now.
