Young At Heart

One of Loudon's best kept secrets was discovered by Loudon's Young at Heart for their June meeting. The group gathered at the 900-acre Sanborn Mills Farm off Pittsfield Road for a very interesting tour of the gardens and grounds.

Kelly, head gardener, started our journey by explaining many of the heirloom plants in the terraced garden. She told about excavation of a banking adjacent to the house to allow for rock walls and a waterfall to be built. The walls were a joint effort of many local craftsmen.

In bloom were gorgeous, gigantic iris, peonies, roses and a large field of lupine among others.

A short walk took us down the hill to see the water powered up and down saw mill. It is one of only two in the state. Water drains from a large mill pond across the road and turns the turbine located in the mill's basement. This then operates the saw. Brian, the sawyer, and his son patiently answered the group's many questions.

Later, owner Colin Cabot, told the group about the time the dam was breached due to ice. It has long since been rebuilt abiding by a lot of government regulations.

The water power is also used to run the grist mill where corn and other grains grown on the property are ground into flour.



Lunch was a culinary treat of food grown on the farm. Kudos to chef Kelly for some delicious dishes including a mashed potato and golden beet combination. The meal was eaten on lovely tables made from various woods harvested on the property.

Mr. Cabot told the Young at Heart about purchasing the property in 1994 and moving in in 1995 and how there were still many works in progress.

One of these is the former Loudon Surprise Grange No. 121 that sat in Loudon village for many years. In February of 2014 it was moved to Sanborn Mills Farm and is being renovated for use by the public for meetings and workshops. Some members of the group recalled performing on the stage of the Grange Hall, attending scout or 4-H meetings or graduations or even cutting up firewood for the wood stove for meetings.

Much has been done and continues to be done to restore the Grange Building to its earlier condition. Sixteen brand new windows with 40 (yes, 40) panes each are part of that work.

During their travels around the grounds folks were able to witness a team of Devon oxen and a hitch of work horses being exercised. These animals are used to do some of the haying and to twitch out logs from the woods.

Young at Heart is open to any Loudon resident 55 years old or older. Meetings are held the second Tuesday of the month at Faith Community Bible Church at 10:00 AM. There are no meetings in July and August. The group will kick off the fall season with a cookout at the Villages of Loudon on September 12 at 11:00 AM. We'd love to have you join us.

END OF SCHOOL:


NASCAR:



The Loudon Fire Department has had an average year of emergency call activity. The number of calls is just cresting over 400 calls for emergency service.

The department continues to meet our goal of being on the road in under two minutes, 100% of the time, from the moment the pager goes off until the first unit is on the road. In the last month the longest response time to have the wheels turning was one minute and fortysix seconds, day or night. With 47.5 square miles of town to cover we are able to get our first piece of apparatus on the scene safely in under 10 minutes, day or night. We are averaging about seven minutes and thirty seconds during the day and ten minutes and twenty seconds at night.

The Loudon Fire Department is an agency which primarily uses members responding to emergency calls from home. The members have to go to the station to pick up a piece of apparatus, with the exception of the 2 duty personnel. We are doing very well regarding our safe response times.

This spring we have focused on a lot of training. Many members have completed several courses of study. Firefighters Brady Leonard and Ethan Lavoie completed the NH Firefighter Level II certification programs. Firefighter Cadence Solsky completed the Fire Instructor I certification. Lieutenant Matthew LaDuke completed the Fire Instructor III certification program. Paramedic Kelly Dellovo completed field training and is now cleared to work independently as a Paramedic.

Firefighter Sean Marden has completed a three-day course to



become a certified car seat inspector. The Loudon Fire Department now has 2 members in-house that can conduct car seat safety inspections and education programs.

Firefighters Brady Leonard, Sean Marden, Sarah Lewis, and Nathan Eckers have completed the All-Apparatus Driver Operator Course through the NH Fire Academy.

Firefighter Sara Frenette and Chief Blanchette have completed a 2-day Wildland Portable Pump course conducted at Bear Brook State Park. Firefighters Eric Tucker, Chris Warren and Sara Frenette have completed a 6-day Wildland Firefighter course conducted at Bear Brook State Park.

Firefighter Paris Chartrand completed the NH Firefighter Level I & II certification program through Lakes Region Community College.

Beyond the training accomplishments previously acknowledged, members of the department participated in training 3 Monday nights each month as well as 2 days a week to keep their skills sharp and to learn new skills.

We want to acknowledge the Loudon Firefighters Association for their fundraising efforts in support of the Fire Department. In June members of the Association purchased a Wildland Fire Danger sign for station two on Clough Hill. The sign was purchased at a cost of \$2,300. The sign was installed by the Association so that community members on that end of town can be reminded of the current fire danger status and the importance of obtaining the proper fire burning permit.

The Association also purchased a Nitrox pain control unit for one of our two ambulances. Nitrox is very similar to the gas you may have received during a dental procedure. The Nitrox pain control unit reduces the number of times other pain control medications are utilized. The cost of this unit was \$4,500. The Association is raising funds to purchase a second unit for our other ambulance.

With summer upon us we want to take a moment to remind you of a few summer safety tips:

1. We have provided loaner life jackets at the Clough Pond Beach to be borrowed for swimming and cooling off. Please return them to the box when done.

2. We have FREE bicycle helmets and bicycle lights for anyone who shows up at Station 1 during normal business hours.

3. Lightning may strike 10 miles away from any rain. If you hear thunder, you are in the danger zone and should take shelter inside a home, large building, or hard topped vehicle right away.

4. When you hear thunder; taking shelter under a tree is not a safe.

5. Wait at least 30 minutes from the last sound of thunder before returning to outdoor activities.

6. Fireworks are fun to watch but should only be used by safety minded adults.

7. Children between the ages of 10 - 14 had the highest rate of fireworks injuries last year.

8. Nationally, In the two-week period last year around the 4th of July, serious BURN injuries accounted for 44% of all fireworks injuries.

9. Sparklers are pretty and may seem safe but burn at 1200 degrees Fahrenheit.

10. More than 19,500 fires are ignited annually nationwide from fireworks

Here's a mixture of recipes I have found that sound interesting. Cucumber, Tomato and Avocado Salad

2 ripe avocados 1/3 cup fresh Cilantro 1 English cucumber, thinly sliced

- 1 red onion, chopped
- 1 ½ lbs. Roma tomatoes, cut in quarters
- 2 T. lemon juice
- 1 tsp. sea salt/black pepper
- $2\frac{1}{2}$ T extra virgin olive oil

Mix lemon juice and oil. Toss remaining ingredients and pour over veges.

Roasted Herb Tomatoes

3 medium to large, firm, ripe tomatoes
1 cup fresh bread crumbs
2T olive oil, plus some additional for drizzling
1 large clove garlic, minced
1T parsley, snipped
salt and pepper to taste
¼ cup Parmeson cheese

Cut tomatoes in half crosswise. Gently remove seeds and juice. With a small knife, trim away stem end. Mix bread crumbs, 2 T olive oil, garlic, parsley, salt and pepper. Top tomatoes with bread crumb mixture and cheese. Drizzle additional oil on top and place in an oven proof pan. Bake at 350 degrees about 15 - 20 min. or until tomatoes are heated through, slightly softened and bread crumbs begin to brown.

Garden Squash Frittata

5 eggs 1T. butter 1 T. oil 1 large onion, coarsely chopped 1 small zucchini (trim and slice thin) 1 small summer squash (trim and slice thin) 1T. snipped parsley ½ tsp. thyme salt and fresh ground pepper

Beat eggs with a fork in a medium bowl – set aside. Melt butter and oil in a large fry pan. Add onion, zucchini, squash and saute' until vegetables are golden brown. Add parsley, thyme and salt and pepper to taste. Pour eggs over veges and cook on low heat. Stir occasionally so uncooked eggs run to bottom of pan to cook. Cover with a lid to set top of eggs.

Shredded Green Chile Beef

(From Taste of Home)

2 large sweet onions4 T. brown sugar, divided1 T. paprika1 tsp. cayenne pepper 1 tsp. chili powder

tsp. garlic powder
 ½ tsp. salt
 ½ tsp. pepper
 boneless beef chuck roast (about 3 #)
 T. canola oil 1 can
 (28 oz.) green enchilada sauce

Place onions and 3 T. brown sugar in a 5 or 6 qt. slow cooker. Combine remaining brown sugar and next 6 ingredients. Coat beef with mixture. In a large fry pan, heat oil over medium-high heat; brown beef 1-2 min. each side. Transfer to slow cooker. Pour enchilada sauce over beef. Cook covered on low until beef is tender, 7-9 hours. Remove beef, shred beef with 2 forks and return to slow cooker to heat through. Serve over potatoes or in buns.

Cool Chicken Salad with Peanut Dressing

1 large head romaine lettuce
2 naval orange, peel and cut in wedges
1 1/2 lb. cooked chicken, cut into bite size pieces
1 cucumber, peeled and cut into crescents
8 scallions, finely chopped
1 wedge red cabbage (6 oz), thinly sliced
3 T. sesame oi
2/3 cup corn oil
¼ cup rice vinegar
¼ cup crunchy peanut butter
2 T. tamari
½ tsp. dried red pepper flakes

Wash lettuce and place in a large salad bowl. Cut the orange wedges crosswise into thirds. In a medium bowl, combine oranges with the chicken, cucumber, scallions and cabbage. Toss to mix. In a medium bowl, whisk together the oils, vinegar, peanut butter, tamari and red pepper flakes.

Pour 1/3 of dressing over lettuce and mix thoroughly. Pour remaining dressing over chicken mixture and toss. Spoon chicken over lettuce placed on individual plates.

Strawberry Rhubarb Scones

2 cups flour
3 T. sugar, plus some for sprinkling
1 T. baking powder
¼ tsp. salt
6 T. cold, unsalted butter, cut into pieces
1 cup strawberries, hulled and cut in quarters
1 cup rhubarb, cut in 1 in. pieces
zest of 1 lemon
1/3 cup heavy cream
2 eggs, lightly beaten

Preheat oven to 350 degrees. In a large bowl, whisk together the dry ingredients. With your fingers or a pastry cutter, blend in the butter until it forms small peas.

Gently stir in strawberries, rhubarb and lemon zest. In a small bowl

mix cream and eggs together. Make a well in the dry ingredients and add liquid all at once. Mix with a fork just until dough comes together. Turn out on a lightly floured board or counter and knead a few times to mix well. (Do not over do the kneading. The less the better for tender scones.)

Pat dough into a circle about 1 to 1 $\frac{1}{2}$ in thick. Cut into 6 wedges and transfer to a layer of heavy duty foil. Place on baking sheet. Brush tops with cream and sprinkle with sugar. Bake 20 – 25 min or until golden brown. Remove from oven and cool on a rack before cutting.







SUMMER SWIM LESSON PROGRAM – 2023 SUMMER SWIM LESSONS

The Loudon Recreation Committee is once again partnering with SWIM NH to offer Red Cross swimming lessons at Clough Pond. Small group lessons will be offered in one-week sessions, classes running Monday-Thursday with an inclement weather make-up day on Friday if needed. The first session is anticipated to begin on July 17th with the last session to end on August 10th. Each session will cost \$30 per child with a family rate of \$90 maximum. 

In May 2023 the Loudon Food Pantry gave out enough food to 313 individuals for them to prepare 5,281 meals. Of these people, 184 were aged 60 and older (59 percent), 52 were aged 18 or under (17 percent), and 77 were between those ages (25 percent).

Our elderly guests use soup as a meal when they don't really feel hungry (but know they need to eat something) or just too tired to cook. Others use soup as a supplement to sandwiches. The typical food allotment to give out to a single person is nine meals for three days. This is under the assumption that the person also receives SNAP (Food Stamps) as a supplement to the food received. Unfortunately, not everyone qualifies for the SNAP program.

So, after reading many different articles about how pantries feed their guests, we decided to try something different. One article said that after one or two trips to a pantry and receiving a larger amount of food (to feel secure), most guests will start to take just what they need. They will always keep a little extra in case they can't make it to the pantry that week (i.e., sick child, appointments, etc.). We did it and it works! We have quests that feel more food secure and takes less than what we offer them on a weekly basis. If they can't make their appointment to get food, they call and now tell us not to worry. They'll be okay for the week!

With your help, we can continue helping people feel food secure!

Town of Loudon, New Hampshire Planning Board Public Hearing Minutes May 18, 2023



Chairman Jeff Green called the meeting to order at 7:01 PM.

Attendance: Mr. Forrest Green, Ms. Marilyn Whitten, Mr. Josh Pearl, Mr. Rodney Phillips, Chairman Jeff Green, Vice-Chair Danielle Bosco, Ex-Officio John Storrs, Alternate Bob Phillips, Alternate Bill Taranovich

Also present was Deputy Chief Bill Lake from the Loudon Fire Department.

Acceptance of Minutes:

April 20, 2023, Regular Meeting Minutes – Mr. Rodney Phillips suggested an edit to line 151 changing "say" to "prove", and an edit to line 176 changing "conditions of approval" to "conditional approval". A motion was made by Mr. Rodney Phillips to approve the minutes as amended; the motion was seconded by Vice Chair Danielle Bosco. All in favor, the motion passed to approve the April 20, 2023, regular meeting minutes as amended.

Discussion:

Mr. Wayne Lombardo was present as a follow up from last month's conversation about map 47 lot 18. He was seeking information about a subdivision that was preliminarily approved in 1988. Two of the lots have since been approved and built upon. He wanted to know why the subdivision as presented in 1988 would not be approved today. It was clarified that it was a preliminary approval subject to final approval of the Planning Board which had never been finalized. Chairman Jeff Green had a letter from surveyor Web Stout in which he was told to remove the preliminary lines from the plan. The subdivision would need to go through today's subdivision standards as there was no evidence the plan was ever approved in finality.

Mr. Wayne Lombardo asked what was acceptable for moving forward for a proposed subdivision and whether the lots needed to be resurveyed. The lots would need to fit into a 180x240 "box". The lots would require a wetland survey and state subdivision approval. He asked about the issue with steep slopes, but without surveyed plans, the Board could not provide input.

Public Hearings:

Old Business –

Application #23-02 – Tax Map 11 Lot 27 – Benjamin Franklin Charter School

The Board received letters from the Pembroke and Chichester Planning Boards with no concerns regarding DRI.

Abutters present included Dean Van Norden of 143 Chichester Road

and Greg and Gretchen Tetreault of 53 Wellington Lane.

Mr. Jon Rokeh and Ms. Marcie Ouellette presented to the Board.

Mr. Jon Rokeh discussed the proposed additions to the building and the driveway modifications made for pickups and drop-offs. There were now 55 spaces for parking. A traffic study was completed for the property and the area. For picking up and dropping off students, the front area would be primarily used and there would be staggered drop-off times to reduce congestion and help with control. The upper parking area and driveway would have a turnaround and there could be stacking for 35 cars.

All existing wells and septic systems are to be upgraded. The well would be considered a public water system and will require approval from the state.

In terms of fire protection, the new proposed cistern location would be permanent. Gravity would feed the fire pump. The proposed plan works for everything currently on the plan and all future build out.

The car drop-off lane would have stacking for 19 cars. The school will monitor traffic upon opening. There will be signage on the road for "No Stopping" and "No Standing". The school will have a real-time monitor for drop-offs to ensure the lower parking lot is running smoothly. If traffic is a concern, the Planning Board will look into it. A traffic light at the intersection of 106 and Chichester Road is proposed for 2025. If something doesn't go well or isn't working, it will be addressed immediately, and they will move forward from there.

Brett Cole from Granite Engineering presented the plan to the Board. He showed the grading and drainage plan with a bioretention pond at the bottom left corner of the property and a retention pond at the bottom right corner of the property to help with drainage. He explained the utility plan with the well, cistern, and septic, and the erosion control plan. He explained the lighting plan and the plan to have motion lights at night with lights on a timer. He explained the landscape plan to buffer Chichester Road.

Bill Frisella from North Point Construction discussed the architectural plan. He explained most of the work would be done on the internal parts of the building. The existing breezeway would be demolished, and they would utilize the existing garage footprint. The car port would be used as cold storage for the woodshop in the existing garage location. There would be some foundational work with a four foot frost wall. The architectural plans for the classrooms, basement, offices, bathrooms, and multipurpose room were discussed. If the budget allows, new windows and siding will be installed. The entire building will get a new roof. In the annex building, there would be very little renovations.

Mr. Dean Van Norden of 143 Chichester Road had questions about traffic, a possible police presence, the lighting and shooting across the street. The Board discussed full cutoff lighting and downlighting on the building. The concerns about shooting across the street were addressed and resolved.

Mr. Jon Rokeh has a gentlemen's agreement with Continental for overflow parking on their property for events.

Mr. Greg Tetreault of 53 Wellington Lane asked about the plan for a new well and if there would be a heavy draw on neighboring wells. Mr. Jon Rokeh said there was a 125' radius from the wellhead and

was nowhere near property lines, so there should be no concern.

Ms. Alicha Kingsbury of 293 Bear Hill Road discussed her opinions about traffic. She does not feel that traffic onto Chichester Road would be a concern. In comparison to the elementary

school with 450 students and a traffic nightmare, this would not be a concern. She believes the school proposed a good plan.

Mr. Jeff Leonard of 58 Mudgett Hill Road asked about school safety and plans if there was shooting across the street. Ms. Marcie Ouellette explained that the school would always follow the proposed safety plan during any concerning situation.

Mr. Forrest Green confirmed that the cistern would be 20,000 gallons and that the plan would be updated to reflect this. He confirmed there would be 56 total spots for parking.

Chairman Jeff Green discussed sidewalks and how students would get between the buildings. He proposed adding walkways and stairways. He discussed the cistern and sprinklers and them being fully accessible by fire truck. The purpose of the pump shed is to power the sprinkler.

Vice-Chair Danielle Bosco had concerns about the entrance being a single door rather than a double door with a vestibule. The school representatives explained that there was no required rule for a double door, but they would reevaluate if it was an issue.

The public hearing was closed at 9:19 PM.

Chairman Jeff Green opened it to Board Discussions. Mr. Rodney Phillips said that his concern was drop-off, but an annual review would be key. The school would be proactive with pickups and drop offs. The plans were very complete. The conditions were not very risky.

Mr. Rodney Phillips made a motion to conditionally approve Application #23-02 with the following conditions given that the proposal and opinion of the Planning Board complies with the Loudon Zoning Ordinance and the Loudon Land Development Regulations based on the plans presented: (1) Add security lights to the luminaire schedule, (2) Add sidewalks, (3) Update cistern plan, (4) State septic and well approval, (5) Pending review of Stormwater Management by the town's engineer, Nobis, (6) Annual traffic review through June 2030, (7) Report any traffic backups on Chichester Road to PD and Planning Board. Mr. Forrest Green seconded the motion. There was no further discussion. All voted in favor, the motion carried. Application #23-02 was conditionally approved.

Chairman Jeff Green recused himself. Vice Chair Danielle Bosco took over. Mr. Bob Phillips and Mr. Bill Taranovich were moved to voting members. The Public Hearing was opened at 9:33 PM.

Application #22-14 John C. Johnson – Tax Map 2 Lot 21 – Site Plan

Mr. Jeff Green was the land surveyor present. The project was reviewed by the engineer in 2020 and in October 2022. Everyone was now on the same page. The digital copy of the plan was in the PB/ZBA Office. He was hoping for conditional approval subject to final engineer approval. He has made all the changes requested by Nobis and would change anything else if necessary. The Public Hearing was closed at 9:40 PM.

Board Discussion was opened. Mr. Rodney Phillips made a motion to conditionally approve Application #22-14 with the following condition given that the proposal and opinion of the Planning Board complies with the Loudon Zoning Ordinance and the Loudon Land Development Regulations based on the plans presented: (1) Obtain final engineering review and approval. The motion was seconded by Ex-Officio John Storrs. All in favor, the motion carried. Application #22-14 was conditionally approved.

New Business -

Application #23-03 3GG LLC – Tax Map 50 Lot 12 – Site Plan

Mr. Jeff Green presented to the Board. No abutters were present.

Mr. Josh Pearl made a motion to accept the application as complete. The motion was seconded by Ms. Marilyn Whitten. All in favor, the motion carried. Application #23-03 was accepted as complete.

Mr. Josh Pearl made a motion to accept the application as not a development of regional impact. The motion was seconded by Ms. Marilyn Whitten. All in favor, the motion carried. Application #23-03 is not a development of regional impact.

The public hearing was opened at 9:48 PM.

Mr. Jeff Green explained he was presenting an existing conditions plan updated to match the site. The building was proposed to be placed on the rear of the property with an office on top of storage. They were going to level out an area on top for storage. He proposed to add fencing across the front of the lot with an electric gate for security. There would be pole lights across the front parking. It was proposed to widen the front entrance to 22 feet to make it easier for the cranes to enter. The drainage plan remains consistent. There were added catch basins and added retention ponds. There would be a guardrail system along the driveway.

There is currently an application with the ZBA for a reduced setback for the driveway.

Alternate Bob Phillips brought up the need to vent the well.

Deputy Lake clarified that the note to maintain the driveway for fire apparatus included sanding and salting in the winter to ensure fire vehicles could enter and exit if necessary. Mr. Jeff Green stated that the note was not necessary as it was not required for any other business.

Mr. Jeff Green stated that for grading and erosion control, the pond will maintain excess runoff. A riprap edge will replace gutters to the drywell. There is no issue with leaching. The rakes on the roof for snow are now installed correctly.

Mr. Jeff Green will make sure the elevations are included on the plan. The new well will get a deeded easement for the well radius. The Board requested a copy.

A landscaping company was hired for the grounds. The lighting plan includes full cut-off lights. Photometric numbers will be added to the plans.





Mr. Charlie Aznive was not in attendance. Alternate Steve Ives was moved to a voting member for this meeting.

Acceptance of Minutes:

April 27, 2023, Regular Meeting Minutes:

Vice Chair Todd Phelps made a motion to accept the April 27, 2023, Regular Meeting Minutes as written. The motion was seconded by Mr. Peter Pitman. All in favor, the motion carried; the minutes were approved.

Public Hearings:

Old Business -

#Z23-01 Cobblestone Properties of Epsom – Map 49 Lot 123 – Special Exception to allow Automotive Repair

The board received a letter of correspondence from Attorney Giroux requesting a continuance to the June 22, 2023, meeting.

Vice Chair Todd Phelps made a motion to continue Application #Z23-01 to the June 22, 2023, meeting. The motion was seconded by Mr. Peter Pitman. All in favor, the motion carried; Application #Z23-01 was continued to the June 22, 2023, meeting.

New Business –

#Z23-10 Robert & Amanda McCullen – Map 38 Lot 8-4 – Special Exception to Allow for a Reduced Setback for a new garage, existing shed, and driveway (amended)

Vice Chair Todd Phelps made a motion that Application #Z23-10 did not constitute a Development of Regional Impact. The motion was seconded by Mr. Steve Ives. All in favor, the motion carried; Application #Z23-10 was not a Development of Regional Impact.

Mr. Robert McCullen presented to the Board. No abutters were present. He was requesting a Special Exception from Article II Section 204.5 to allow for a reduced setback to allow for an existing woodshed and a new garage. He has a narrow lot of about 200' wide with limited buildable area. If he were to build the shed closer to the house, it would impact an existing hill and walkout basement and then require an extensive retaining wall. The existing woodshed is 12 feet to the property line. There is an existing 30 foot tree line buffer that is filled in during the warmer months as a barrier between his property and the neighbor's. The driveway was added to the application as an amendment as it was within the side setback. The distance from the new

garage to the neighbor's house would be approximately 100 feet. The Board determined that a site walk was not necessary. The Board reviewed the points of the application.

Chairman Earl Tuson closed the public hearing and opened board deliberations.

Vice Chair Todd Phelps made a motion to approve Application #Z23-10 as amended. The motion was seconded by Mr. Steve Ives. Roll call vote: Mr. Steve Ives – yes, Mr. Alvin See – yes, Chairman Earl Tuson – yes, Mr. Peter Pitman – yes, Vice Chair Todd Phelps – yes. All in favor, the motion carried. Application #Z23-10 was approved as amended.

#Z23-11 Derek & Rene Bolduc – Map 28 Lot 20 – Special Exception to Allow for a Detached ADU

Mr. Alvin See made a motion that Application #Z23-11 did not constitute a Development of Regional Impact. The motion was seconded by Mr. Peter Pitman. All in favor, the motion carried; Application #Z23-11 was not a Development of Regional Impact.

Ms. Rene Bolduc presented to the Board. Mr. Dennis Vincent of 7388 Oak Hill Road was present as an abutter.

She was requesting that a Special Exception from Article V Section 509 S to allow a currently existing ADU be allowed as permitted on their property. The ADU existed on the property when she and her husband purchased it 20 years ago. The ADU was approximately 608 sq. ft. without the slab and approximately 900 sq. ft. with the slab. It was 1 bedroom. The existing well on the property would supply the water to the ADU. There were currently 2 septic systems on the property. It was discussed that they may need to update the tank to meet NH DES requirements. The electric is fed off the house and they were not planning on metering the ADU. There is currently a kerosene heater in the ADU, but they will likely get a split unit that is more efficient.

Mr. Dennis Vincent was in favor of the application and would like to see the building utilized.

The Board reviewed the points of the application.

Chairman Earl Tuson closed the public hearing and opened board deliberations.

Vice Chair Todd Phelps made a point that the detached ADU was appropriate per the approval at the Town Meeting in March.

Vice Chair Todd Phelps made a motion to approve Application #Z23-11. The motion was seconded by Mr. Alvin See. Application #Z23-11 was approved.

#Z23-12 Stephen Beliveau – Map 54 Lot 33 – Special Exception to allow for a Reduced Side Setback for a new shed

Vice Chair Todd Phelps made a motion that Application #Z23-12 did not constitute a Development of Regional Impact. The motion was seconded by Mr. Steve Ives. All in favor, the motion carried; Application #Z23-12 was not a Development of Regional Impact.

Mr. Stephen Beliveau presented to the Board. There were no

abutters present. He was requesting a Special Exception from Article II Section 205.5 to reduce the side setback to 15' to allow for a new shed to be installed. He amended the application to add "reduce to 15' setback". There was a limited amount of buildable area on his lot due to the pie-shape of his lot. The new location of the shed did not appear to be in the wetland.

Mr. Jeffrey Green, land surveyor for 3GG LLC, presented to the Board. There were no abutters present. The project is currently in front of the Planning Board for a site development plan as well.

He was requesting a Special Exception from Article II Section 206.5 (amended, was previously 204.5) to reduce the side setback to 13.5' to allow for a proposed driveway on the North property line. The driveway would be at an 8% slope and it was the on the less steep grade of the property. The proposal was limited by the steep slopes on the property. The best location for the driveway in terms of the grade of the slope was on the right side of the property. There was a 2' swale to the right of the driveway. did not constitute a Development of Regional Impact. The motion was seconded by Mr. Peter Pitman. All in favor, the motion carried; Application #Z23-14 was not a Development of Regional Impact.

Mr. Richard Bilodeau presented to the Board. There were no abutters present. He amended his application to add RR to the zone.

He was requesting a Special Exception from Article 2 Section 204.3 (E) to allow for a Major Home Occupation. He installs aftermarket accessory equipment (lights, siren, police cages) in emergency public safety vehicles in his two-bay garage. He also transports trailers from one location to another. He wanted to add a 1 bedroom dwelling over his existing garage. The septic on the property currently has a 1000 gallon tank. This will be addressed with code and may need to be replaced depending on their decision. There is currently electricity above the garage but no water and no heat. Mr. Richard Bilodeau amended his application to complete the missing page. The Board reviewed the points of the application.

Mr. Richard Bilodeau explained that he was running a transport business and required approval for a Special Exception for a Major Home Occupation (204.3 E) to be approved for the transport plates he was requesting from NH DMV. He picks up trailers from locations and transports them to another location. Some of the vehicles do not have plates on them and the transport business provides transport plates. It is all part of the same business that he runs.

I. Chairman Maxfield called the meeting to order at 6:00pm.

II. Selectman Miller made a motion to accept and approve the Consent Agenda as listed. Seconded by Selectman Storrs. All in favor. Motion carried.

III. Chairman Maxfield opened Board of Permit. Rodney Phillips is present to represent the Planning Board.

a. The Board received information from Mountain View Stables Wedding & Events 2023 Season on School Street.

b. The Board received a Special Event License Application from Patrick Dumont, 284 Bear Hill Road for a farm to table dinner with live music. The event is to take place on Saturday June 17th. Selectman Miller said it is a first-time event with live music, and he would need an end time for the music. Chief Blanchette said he has been in several times to meet, and he plans to be done by dark. Chief Burgess asked if the applicant plans to hire a police detail. Chief Blanchette said he recommended it. Chief Burgess said he would reach out to him.

a. Russ Pearl stated the old loader has a hydraulic leak. He asked the selectmen if he could order the new loader. He was instructed to wait until July 1st, 2023.

V. The Board met with Police Chief Kris Burgess:

a. Chief Burgess said Jordan completed physical fitness entrance exam on Tuesday and did very well.

b. Chief Burgess said during motorcycle week they will be utilizing speed enforcement funds. There will also be double coverage for majority of the week.

c. Chief Burgess gave some statistics for the year of 2023. There were 514 citations, 51 arrest, 257 incidents, and 30 accidents.

VI. Agrant amendment notice for the police department was presented to the board. The grant total was increased from \$8,200.00 to \$16,824.33. The grant would purchase 5 printers with paper, 5 printer mounts, an in-car radar unit, and one Lidar radar unit. Selectman Miller made motion to accept the grant; Selectman Storrs seconded it. X. Selectman Miller said there was a request for an ambulance service write off. Account numbers 210000859 for \$290 and 220000109 for \$920. The total amount was for \$1,210. Selectman Storrs seconded the motion. All in favor. Motion carried.

XI. Chairman Maxfield presented Detail pay rates for the Police Department. Chief Burgess will discuss this with Mr. McGrath. The board will further discuss at the next meeting.


