

Loudon has historically been a farming-based community since its inception, and the Loudon Elementary School is involved in continuing to encourage such a connection between the community and land in the many agriculture-related activities that it offers the children attending the school. From field trips to Loudon farms, to vegetable gardens at the school, students are able to experience many aspects of the role farms play in their community and how those farms produce the wide variety of food available to them and their families here in our town.

For many years, the first grade classes at LES have enjoyed an annual autumn field trip to Meadow Ledge Orchards on Route 129. There the children learn about many aspects of tree fruit production including the important

mum of 40 hours working on the project alone. I love to read and I know how important it is for younger kids to have options for books that they will like and have access to easily in order to enjoy reading as well. I am also very passionate about recycling and reducing our negative impacts on the environment. I wanted there to be a place where kids could recycle books for free and get new ones to read; a free book swap bin for kids, made by a kid.

I met with the principal of the Loudon Elementary School and presented my ideas for the project. We discussed details and I was given permission to get started. I drew some sketches and figured out measurements for the bin. Luckily my dad had much of the materials needed for me to build the bin. I did all the measuring, cutting, painting, staining, and lettering on it by myself.

To fill the bin, I spent a lot of time going through old books at my house. I also asked for and received donations of books from other Girl Scouts in Loudon (thank you!!) to get the bin started. I created a flyer and posters to distribute about the proiect for the school.

"Read-Return-Rediscover — The Gift of a Good Book" is the name of the book swap bin. Read — open a book, and a whole new world to explore. Return in your books you are finished with and drop them off in the bin. Rediscover pick out some books from the bin to read and enjoy. You can keep them, or return them to the bin for others to enjoy, either way it is up to you! With the help of my troop this name was created to be similar and familiar to the Reduce-Reuse-Recycle of everyday trash and used recycle arrows that are blue instead of green for my

I hope that this project is enjoyed by many readers and is a success. This is a FREE book bin and will be available the entire school year and for years to come. # "Scouting the Future" **Jamboree Held**

the 2011 New Hampshire Boy Scout Jamboree "Scouting the Future" was held October 7–9 at Waterville Valley. There were 18 boys and chaperones who attended from Pack 247 in Loudon, with a total of over 2,000 Boy Scouts from all over New Hampshire. A full day of exhibits and hands-on activities for Scouts and Venturers was built around the four sections of the Scout Handbook: Scoutcraft, Woodcraft, Camperaft, and Continuing the Adventure. Webelos of local Pack 247, who are transitioning from Cub Scouts to Boy Scouts, had the opportunity to spend the weekend and the chance to try some of the more challenging scout experiences and skill building exercises. Tigers, Wolves, and Bears were invited to attend the day on Saturday. Exhibitors during the jamboree included: U.S. Forest Service, NH Fish & Game, Army National Guard, NH State Police, Waterville Valley Dept. of Safety, NH Marine Patrol, U.S. Postal Service, Meredith SCUBA, Central NH Amateur Radio Club, Trout Unlimited, New England K-9 Search and Rescue, Appalachian Mountain Club, and M.I.T. Robotics. In addition to scout activities and demonstrations, campers were able to enjoy Waterville Valley Resort activities such as boating, biking, ice skating, chairlift rides, and indoor climbing at reduced rates. The day concluded Saturday night with campers enjoying live entertainment featuring the popular MTV's cover band The Zoo. role that bees play in pollination, the equipment and techniques used by pickers to minimize damage to the trees, and how apple cider is produced. After a wagon ride into the orchard, the children are able to try their own hand at picking fruit that they are able to bring home and share with their families.

Loudon is home to a large number of maple syrup producers. Larry Moore of Wind Swept Maples on Loudon Ridge Road has been welcoming the first grade classes late in the winter for over a decade, right as the maple sap is flowing. Visiting the sugar bush, the children are taught about what trees are suitable for sap production and how it is drawn from the tree and gathered. Moving into the sap house, they learn about the great effort involved in boiling the sap down to produce the sweet syrup. Grading and sampling the syrup are a highlight of their day, but not the end, as the Moore's also open up their barn to the students. Young lambs are always a delight for the children to pet, and they are able to learn about the beef cattle that Windswept Maples also raises.

In recent years, a few new activities have been added. In November of 2010, the Loudon Recreation Committee put on a Farm Feast at the school cafeteria. Members of the community were able to come and enjoy a wide variety of dishes produced largely from

the products of Loudon farms. This event was successful, and will be repeated this coming November as well

2011 saw the introduction of a school garden at LES. Organized largely though the efforts of Loudon parent Melissa Minery, kindergarten and third grade students planted a variety of vegetables and flowers in three raised bed gardens constructed on the school grounds. The children were able to watch the growth of the plants during the spring, and pick some of the resulting produce in the fall. Some of the vegetables were incorporated into meals served to children in the school cafeteria. Numerous Loudon farms and businesses supported this activity with donations of plants and materials, including: DS Cole, Ledgeview Greenhouses, Loudon Building Supply, Moore Construction, Pleasant View Gardens, and Red Manse Farm.

The successful season at the school garden is already prompting discussion of how to enlarge the gardens and allow participation of all grades in coming years. Dana Bousquet, speech therapist at LES, has plans to begin a Garden Club at the school next spring, while the kitchen staff has requested that herbs be added to the crops grown, as well as additional vegetables harvested in the fall, to add flavor, variety, and nutrition to the meals served there.

The school's Environmental Kids' Club has initiated an effort to compost cafeteria food wastes. Once

composted, this material could become available as a fertilizer and soil amendment for the school gardens and result in a reduction in the volume of waste generated at the school.

For the past two years, Earl Tuson of Red Manse Farm on Pittsfield Road, has visited the kindergarten classes to talk with the children about the role farms and farmers play in their community. As the young children share their experiences with gardening at home and visiting farms, Mr. Tuson talks about his organic vegetable farm and helps them appreciate the role farms play in providing the food they require every day.

Through all of these activities, LES Principal Tom Laliberte has encouraged and facilitated this "growth" at the school, stating that "The Loudon farming community and LES have come together over the past couple of years. This experience has been very rewarding and educational for our students. Students learn better when they are able to actively participate in their learning. The students have been able to plant and fertilize seeds and eventually pick the vegetables they planted. The students are more aware of how farms operate and what a great aspect of Loudon they represent. The community has been wonderful in supporting this new joint venture. I hope to see it grow throughout the upcoming years."



# This month: The Season of Eating!! Holiday Food

November is here and it is officially the season of eating! My favorite part of the holidays is FOOD...and lots of it! As we all are running around crazy trying to attend every party, event and social gathering it can be tough to whip up something quick a delicious so you don't arrive empty handed. Here are a few of my favorite go to recipes sure to please a crowd.

# **Original Ranch Spinach Dip**

This is by far my favorite spinach dip. Many spinach dip recipes call for mayonnaise which I think makes it much too rich for the amount of dip I eat at a time. I almost always double the recipe and serve it in a pumpernickel bread bowl.

- packet (1 ounce) Hidden Valley Original Ranch Dip Mix
- 1 container (16 ounces) sour cream
- box (10 ounces) frozen chopped spinach, thawed and well-drained
- 1 can (8 ounces) water chestnuts, rinsed, drained, and chopped
- 1 round loaf French bread fresh vegetable sticks

Stir together dip mix, sour cream, spinach, and water chestnuts. Chill 30 minutes or until just before serving. Cut top off the bread and remove center (using firm bread pieces as dippers). Fill bread bowl with dip. Serve with cubed bread and vegetables.

# **Sweet and Spicy Kielbasa**

Last month I made some really yummy grape jam that never got thick. I had to reprocess the whole batch but as I was brainstorming all the ways I could make use of delicious grape syrup I remembered this recipe and decided to keep some of the syrup special for this (and PB and J smoothies) It is always a hit at parties.

- 2 pounds kielbasa
- 1 can of pineapple chunks, drained
- 2 cup of grape jam/jelly
- 1 cup of your favorite mustard
- 2 Tbsp chili sauce

Slice Kielbasa 1/2-inch thick. Mix jam, mustard, and chili sauce in slow cooker/crock pot. Add sliced Kielbasa and pineapple and mix until covered. Set slow cooker/crock pot on low to cook for 2 hours.

# **Mushrooms With Smoked Mozzarella**

Keeping Athens Fillo (phyllo) dough cups, found in the freezer section of the grocery store, on hand makes it easy to throw together a quick appetizer or dessert.

- 2 teaspoons canola oil
- 1/2 teaspoon minced garlic
- 1½ cups small-diced mushrooms
- 2 tablespoons small diced onions
- 1 teaspoons capers
- teaspoon Worcestershire sauce
- 1/4 teaspoon dried leaf thyme
- 2 tablespoons red wine Dash of salt and pepper
- 15 Athens<sup>®</sup> Mini Fillo Shells (1 box)
- 3 tablespoon shredded smoked mozzarella

In a small skillet heat oil, add garlic and sauté for 1 minute. Add mushrooms, onions, capers, Worcestershire, and thyme. Sauté for 3–5 minutes. Add red wine and simmer until liquid evaporates. Season with salt and pepper. Spoon 1 rounded teaspoon of filling into each Fillo Shell. Top with 1/2 teaspoon of mozzarella cheese. Bake in preheated 350°F oven for 5 minutes. Serve warm. Makes 15 Appetizers.

# **Pumpkin Mousse**

My friend Julie made these for me for my birthday last year and had me meet her in the parking lot of LES to give them to me. She handed them to me in a pretty ceramic dish so I could get them home safely. They were so yummy...that I at every one of them right then and handed her the dish back.

- 1/2 cup canned pumpkin pie mix
- 3 tablespoons prepared vanilla pudding
- 1/4 teaspoon pumpkin pie spice
- 2 tablespoons thawed whipped topping
- 15 Athens® Mini Fillo Shells (1 box)
- 1/4 cup thawed whipped topping, for garnish

In a small bowl, combine pumpkin pie mix, pudding, and spice. Fold in 2 table-spoons of whipped topping. Chill for 1 hour. Spoon or pipe 1 teaspoon of pumpkin mousse into each Fillo Shell. Garnish with remaining whipped topping. Serve immediately. Makes 15 Tarts

# **Orange Marmalade French Toast Casserole**

Don't forget to plan ahead for those morning gatherings too!

- 1 stick of butter, softened
- 1 16-ounce sourdough French bread loaf, cut into 24 (1/2-inch) slices Cooking spray
- 1 12-ounce jar orange marmalade
- 2½ cups milk (I like to use vanilla almond milk)
- 1/3 cup sugar
- teaspoon vanilla extract
- 1/2 teaspoon cinnamon
- 8 large eggs
- 1/3 cup finely chopped walnuts

Spread softened butter on one side of each bread slice. Arrange 12 bread slices, buttered side down, slightly overlapping in a single layer in a 13 x 9-inch baking dish coated with cooking spray. Spread marmalade evenly over bread; top with remaining 12 bread slices, buttered side up. Combine milk, sugar, vanilla, cinnamon, and eggs stirring with a whisk. Pour egg mixture over bread. Cover and refrigerate for at least an hour or overnight. Preheat oven to 350°. Sprinkle casserole with walnuts. Bake at 350° for 45 minutes or until golden. Let stand 5 minutes before serving.

# Sign Up Now For Snowmobile Safety Classes

Winter is on the way, and snowmobile education classes are now underway across the state. To operate a snowmobile in New Hampshire, any person over the age of 12 must have either a valid Motor Vehicle Driver's License or have successfully completed an approved Off-Highway Recreational Vehicle (OHRV) Safety Education class taught by volunteer instructors trained by the New Hampshire Fish and Game Department. Additionally, all children under the age of 14 must be accompanied by a licensed adult when operating a snowmobile, unless they are on property belonging to their parents, grandparents or guardians.

Sign up soon if you or someone you know needs a class. Most classes take place in October, November and December. There is no charge for the classes, which are usually completed in a single day. Parents are encouraged to attend along with their children. New classes are added as they become available. For a current class schedule, visit http://www.wildnh.com/OHRV/schedule.html.

"Snowmobiling is a great way for families to have fun exploring the great outdoors, but riders have a responsibility to obey the rules of the trails, to be courteous and — most of all — to ride safely," said Captain John Wimsatt, who coordinates Fish and Game's OHRV Education Program.

Many of the trained volunteer instructors teaching the safety classes are affiliated with one of the more than 100 snowmobile clubs in New Hampshire. Joining a snowmobile club is a great way to learn about safe riding, help support local landowners and help maintain trails for your own and others' enjoyment, Wimsatt said, noting that club membership also gives riders a \$30 discount on snowmobile registration fees.

The New Hampshire Snowmobile Association (NHSA) and its member clubs have actively promoted safe and responsible riding since 1969. NHSA members work with Bureau of Trails staff and Fish and Game to manage over 7,000 miles of trails in New Hampshire and provide safety education to more than 2,500 riders each year. In addition to safety education, this winter Fish and Game Conservation Officers will use innovative enforcement patrols to detect and apprehend impaired snowmobile operators, enforce speed limits, deter unlawful off-trail riding and detect machines with modified exhaust. These ongoing initiatives will help to keep the state's snowmobile trails safe for all outdoor enthusiasts during the upcoming season.

# FROM THE FIRE DEPARTMENT

# **Discuss Fire Safety With Your Children**

 $\Gamma$  ire safety in the home is up to us, the parents. It's never too early — or late — to discuss fire safety and prevention with your children. With the holidays approaching and all of the flammable decorations, extra cooking, candles, etc. its a good time to begin the discussion. Use the following fire safety and prevention information to lead discussions.

#### **Control Kids' Access to Fire**

- Keep all matches and lighters out of the hands of children. If possible, keep these sources of fire in locked drawers. Consider buying only "child-proof" lighters—but be aware that no product is completely child-proof.
  - Children as young as two years old can strike matches and start fires.
- Never leave children unattended near operating stoves or burning candles, even for a short time.
- Teach children not to pick up matches or lighters they may find. Instead, they should tell an adult immediately.

# **Fire Safety at Home**

- Smoke alarms should be installed on every level of the home, especially near sleeping areas.
- Smoke alarms should be kept clean of dust by regularly vacuuming over and around them.
- Replace batteries in smoke alarms at least once a year. And replace the entire unit after ten years of service, or as the manufacturer recommends.
- Families should plan and practice two escape routes from each room of their home.
  - Regularly inspect the home for fire hazards.
- If there are adults in the home who smoke, they should use heavy safety ashtrays and discard ashes and butts in metal, sealed containers or the toilet.
- If there is a fireplace in the home, the entire opening should be covered by a heavy safety screen. The chimney should be professionally inspected and cleaned annually.
- Children should cook only under the supervision of an adult or with their permission.
- Children should never play with electrical cords or electrical sockets. They should ask adults for help plugging in equipment.
- Children should stay away from radiators and heaters, and they should be taught that these devices are not toys. Young children in particular must be taught

not to play with or drop anything into space heaters. Nothing should be placed or stored on top of a heater.

- Pots on stovetops should always have their handles turned toward the center of the stove, where children cannot reach up and pull or knock them off.
- Teach children to turn off lights, stereos, TVs, and other electrical equipment when they are finished using them. In the case of room heaters, children should ask an adult to turn it off when the room will be empty.
- Children should never touch matches, lighters, or candles. If they find matches or lighters within reach, they should ask an adult to move them
- No one should stand too close to a fireplace or wood stove or other types of heaters, where clothes could easily catch fire.

# **Warning Signs**

- Evidence of fire play, such as burnt matches, clothes, paper, toys, etc., or if you smell smoke in hair or clothes.
- Inappropriate interest in firefighters and/or fire trucks, such as frequent, improper calls to the fire department or 9-1-1.
  - Child asks or tries to light cigarettes or candles for you or other adults.
  - Matches or lighters in their pockets or rooms.

# **Control Curiosity**

- Talk to your child or students in a calm, assured manner about fire safety.
- Consider visiting a fire station if children are very interested in firefighting and/or fire trucks or ask a firefighter to visit your classroom. Have the firefighter talk about his/her job and the dangers of fire.
- For parents: Create opportunities for learning about fire safety at home. For example, when you cook, let your child get the pot holder for you; when you use the fireplace, let your child bring you the wood or tools; if you use candles, let the child check to make sure the candle holder fits snugly; and when you change or test the batteries in your smoke alarms, ask the child to help you.

# What to Do if You Suspect Your Student/Child Is Playing with Fire?

- Talk to the child about his or her actions. Explain again that fire is a tool for use only by adults, and that it is very dangerous for children.
- Many schools, fire departments and law enforcement agencies have programs for children who are inappropriately interested in fire or who have set fires.

We received information on Square 34, the Yankee Country Store. Jason Fiske thought "A.S." was in all probability Addie Smith, who was an elderly lady his mom used to take care of and cut her hair. She lived across the street from the store and Jason remembers her always walking across the street to visit with the neighborhood ladies.

Michele York sent in a correction. Square 14 information stated the Loudon Freewill Baptist Church was built in 1774. However, it was actually built in 1779.

The quilt is pictured at right. We have ongoing questions about the following squares: 3, 4, 13, 16, 17, 21, 24, 29, 31, 32, and 34.

# "Witches, Pop Culture, and the Past"

The Historical Society had a good turnout for "Witches, Pop Culture, and the Past," on Wednesday, October 19. Thirty people came out on a rainy night to hear Dr. Robin DeRosa's presentation. The audience learned that most of the accused witches were not from the Salem, MA we know, but from Salem Village, now known as Danvers, MA. Most of the original homes of the accused are still there.

If you're interested in finding out more about the Salem Witch Trials, the Danvers Library has a great deal of information. It seems that many people at the evening's talk had distant relatives who were part of the witch trials.



# **Transfer Station Construction In Progress**

Many residents have asked about the construction going on at the Transfer Station recently. After many years of use, the demolition and metal collection areas needed some repairs. Pavement had become broken and the design had become outdated. Mike Milligan and crew from Milligan Foundations in Loudon and the Loudon Highway Department worked together to build concrete "Z" walls in the demolition container area and to add concrete pads as well. A large concrete pad was also installed in the metal collection area to replace the old paved pad. Suburban Paving supplied the new pavement around the new pads and walls.

Besides replacing the old pavement in these areas, the main purpose of the new wall design was to make pick-up and drop-off of the demo containers quicker and easier. Cleanup should also be much easier with the new concrete surface.

Thanks to residents for their patience while we complete this project, and special thanks to Mike Milligan for donating his time and equipment in the site preparation!

On September 15th, 2011, the Concord Regional Solid Waste/Resource Recovery Cooperative (locally known as the Co-op) joint board voted to begin construction of a Single Stream Recycling Facility. Some of you may remember a similar vote was made in June of 2010 to build the facility, contingent on getting 25,000 tons of recycled material per year to be delivered for processing. The Co-op management has been securing contracts from municipalities (both inside and outside of the Co-op membership) since the original joint board vote to proceed.

Many changes have taken place since that time. The greatest change, of course, has been the economic recession. This caused many municipalities to be extra cautious about making changes to their recycling programs. When the economic slump caused recycled material value to fall drastically, municipalities would have had to pay to get rid of some materials rather than getting paid for them. This was obviously not the best time to make the change to Single Stream Recycling!

Since then, recycled material prices have rebounded to more favorable amounts. Co-op officials have been able to obtain contracts for just under 25,000 tons of material. As the economy stabilized, there was more speculation that some other group or business would build the first Single Stream Recycling Facility in New Hampshire. Whoever builds first has the greatest opportunity for success. These factors prompted the Co-op to make the decision to build as soon as possible. The vote to continue passed by an approximate 3-to-1 margin.

The Single Stream project has been the cause of much controversy within the Co-op itself. It is more advantageous for larger communities to participate than for smaller communities. Recently, the towns of Hopkinton and Webster became the first to ever withdraw from the Co-op, over disagreements about how the facility would be financed. In essence, they did not wish to pay for something they weren't planning on using. Because of the population differences (and therefore the number of votes) between the smallest and largest communities, the votes of the 3 cities in the group had the biggest effect. For example, if Concord did not want to participate and voted no, it would not be feasible for the others to continue.

Current timeline projections suggest that this facility could be operating within about 1 year. The Town of Loudon has not agreed to participate at this time, but because of our Co-op membership, could join with no penalty at a later date.



# **Home Maintenance Tips for Fall**

As fall is upon us, see this checklist to preserve the health of your home.

- 1. Clean the gutters: As you clear leaves, dirt, and pine needles from gutters, examine downspouts for damage. Check the flashing around your chimney and look for damage to the roof that may lead to leaks.

- **6. In hot water:** Often, if you live in an area with hard water, extra amounts of sediments build up in your hot water heater. Drain and make sure rust is not developing. ■

# Selectmen's Meeting Minutes — September 13, 2011

Present: Selectmen Ives, Bowles, and Krieger.

Also present were Fire Chief Jeffrey Burr Sr., Police Chief Robert N. Fiske, and Stanley Prescott from the Planning Board.

Chairman Ives called the Meeting to order at 6:30 p.m.

Selectman Bowles moved to accept the Selectmen's Meeting Minutes of Tuesday, September 6, 2011 as written; seconded by Selectman Krieger. All were in favor. Motion carries

Chairman Ives opened the Board of Permit.

Chief Fiske stated he has two Hawkers & Peddlers permits and one amended permit.

The first is Renegade Playground, an endurance event at the track on October 8. They submitted a map, they have insurance, the track gave permission and the Conservation Commission is on board.

Speedway Charities is holding a silent auction at their lobster bake it is a one day event.

The amended permit is a request by Michelle York. She was given the okay to sell hotdogs at Foxpond Plaza and on Hollow Route Road at the sap house. She would also like to try selling them on dump road. Mr. Fiske stated that he already told her as Health Officer that it couldn't happen inside the dump. Mrs. York said she could ask Mr. Moody about using his property. Chairman Ives stated that unless Mr. Moody agreed for it to be entirely on his property and they could get people off dump road he would

not be in favor of it. Selectman Krieger agreed that dump road already gets congested. Stan Prescott stated that he thinks it would be in the way and not an appropriate location.



Bowles asked if Speedway Convenience knows they need to follow the plan from July's race. Chief Fiske stated that the letter indicates that.

Chairman Ives closed the Board of Permit and resumed the Selectmen's meeting.

The Board met with Chief Fiske.

Chairman Ives stated for the record seven (7) pistol permits were submitted for signature and approval.

The Selectman asked if Chief Fiske has spoken to Kit Thorstensen. Chief Fiske said Kit has the metal for the PD and the Highway Department. They asked Chief Fiske to mention the library roof to him when he talks to him again.

Chief Fiske was asked if knows the date for next year's Indy Race yet? Chief Fiske said that he does not know the date. He brought it up at the DOT meeting. Chief Fiske explained to them at the meeting that if the Timberman is the same day as the race, the race traffic will be held up for 45

The Board met with Chief Burr.

Chief Burr said that the truck committee has been working on getting something together for the budget for a ladder truck. He will have the Selectmen review it before it goes into the budget.

Chief Burr submitted a copy of an updated schedule for the September race. Chief Burr said he delivered the schedule to NHMS today.

Chief Burr stated that he has more information about the emergency exercise drill at the airport. He explained that the FAA requires a full scale exercise every three vears. Loudon has been added to the airport list. The exercise is to get familiar with the airport where to respond, routes to use etc. The exercise will take place October 1. 2011. Discussion ensued about the cost of sending the ambulance that far, how long the training will be, mutual aid etc. Chief Burr will get more information about bringing observers and discuss it next week.

Chief Burr received a handout from Concord Hospital Trust and explained that they do a golf tournament each year. They use the money that is raised for services that use Concord Hospital. This year they have a Mechanical Compression Device. It cost \$18,000.00. If the town is interested in receiving one their share would be \$6,500.00. Chief Burr said there is a woman at the Concord Hospital Trust that will help raise the \$6,500.00 through fundraisers and charities. Selectman Bowles asked what kind of maintenance fees would be required. Chief Burr said that as with anything mechanical it could break. Chief Fiske asked what kind of training would be necessary. Chief Burr said anyone could learn to use it; it only takes 15-20 minutes to learn. The Selectman said that Chief Burr could pursue it but to keep in mind that the \$6,500.00 must be raised it can't come out of the budget.

The Selectmen had questions for Chief Burr about some bills and purchases that were submitted last week. Chairman Ives asked about the purchase of leather boots. Chief Burr stated that leather boots are more comfortable and better on the feet. Chairman Ives said that they don't normally buy leather it used to be rubber. Chairman Ives asked when they started buying leather helmets. Chief Burr said a couple of years ago. Selectman Bowles asked when the decision came up and who made it, to go with this line of boots and helmets. Chief Burr stated that the officers sat down and talked about it. Selectman Krieger asked if they have a clothing allowance. Chief Burr stated they do, the department purchases the items and when a member leaves they take them back and re-issue. Chairman Ives said that he understands the boots but the helmets are just decorative, the yellow fiberglass helmets were fine.

Jim McNeil asked what the specs are for the ladder truck that is being discussed. Discussion ensued as to the kind of truck. Chairman Ives suggested that when the truck committee has the specs for the truck that they hold a public input session before town meeting. Mr. McNeil has concerns about the truck that is being considered. He stated that he doesn't think that the town needs a brand new ladder truck when they can get a used one for half the price

Selectman Krieger told Chief Burr that he needs to put a better explanation on the bills he submits. The Selectmen can't decipher the codes that Chief Burr uses so it's hard to know what is being paid for.

Selectman Krieger moved to go in to a auick executive session at 7:24 p.m.: seconded by Selectman Bowles. Roll call vote: Krieger - yes; Bowles - yes; Ives - yes. All in favor. Motion carried. Present were Selectmen Ives, Bowles and Krieger and Fire Chief Jeffrey Burr Sr. Selectman Krieger moved to come out of executive session at 7:44 p.m.; seconded by Selectman Bowles. Roll call vote: Krieger - yes; Bowles - yes; Ives - yes. Selectman Bowles said that letters need to be written to the other applicants, thanking them for applying and explaining that the position is filled and their applications will be kept on file.

Selectman Bowles said that the crew has been busy at the dump but they should be finished this week. Discussion ensued about a name for the street behind Z-1.

Chairman Ives opened the public hearing at 7:00 p.m. by reading aloud the following Notice of Public Hearing:

The Board of Selectmen of the Town of Loudon will hold a Public Hearing on Tuesday, September 27, 2011 at 7:00 P.M. in the Community Building, located behind the Town Offices. Purpose of this hearing is to amend the Town of Loudon Solid Waste/Transfer Station Ordinance, Section III-h Licenses/Fees as follows:

Increase Individual Residential Sticker from \$1.00 to \$4.00.

Increase Individual Commercial Sticker from \$1.00 to \$4.00.

This increase to become effective with the sale of the 2012 stickers beginning on December 1, 2011.

Chairman Ives explained that during discussions at town meeting about the Household Hazard Waste Recycling Day \$10,000.00 was appropriated to have it every two years. In discussion they came up with the idea to increase the price of the stickers to raise the money so that every two years they are not boosting the budget by \$10,000.00, the money will already be in there to do it. Chairman Ives explained that the reason they choose to go from \$1.00 to \$4.00 is that the town sells about 1800 stickers so they will raise about \$5,400 per year. The town will generate that amount to cover the Household Hazard Waste Recycling Day. Selectman Bowles stated that the stickers are close to \$1.00 each to get made which is why they were charging that \$1.00 before.

Selectman Bowles made a motion to Increase Individual Residential Sticker from \$1.00 to \$4.00 and to increase Individual Commercial Stickers from \$1.00 to \$4.00 for the purpose of raising revenue to support the Household Hazard Waste Recycling Day to begin on 12/1/2011. Seconded by Selectman Krieger

Discussion: Chip Cochran asked what happens as people get rid of stuff, they're not going to have the same amount of stuff every other year, so the money you need is going to go down unless the price to get rid of it goes up. Selectman Bowles said that is an unknown. Mr. Cochran asked what happens if in two years the cost is only \$4,000.00 will the price of the stickers be lowered. Selectman Bowles stated that the money would end up in the general fund at the end of the year. Chairman Ives said that a few years down the road if the sticker price needs to be adjusted they can revisit it. Steve Bennett from the transfer station explained that the two previous collection events cost between \$8,500.00 and \$9,000.00 which is why they picked

\$10,000.00. He further explained that he recently received a notice from Clean Harbors the company that does the event, saying that they will be raising prices on certain things; they weren't specific as to what materials yet. Chip Cochran asked if Clean Harbors is the only company that does this. Mr. Bennett stated that they are really the only ones in the New England area: they are from the Boston area and do everyone in New England. Selectman Krieger stated that within three years this needs to be looked at again in case there is extra money that taxpayers are paying for the stickers. Chairman Ives agreed and explained that this is a start and seemed the fairest way because the people that use the dump will be bringing the household hazard waste and will be buying the stickers. Selectman Bowles said it's easier to have the money in the account rather than raise and appropriate the money every other year. Barbara Sullivan asked if money was appropriated at the last town meeting for this and if so what happens to that money when this new program starts. Steve Bennett stated that the next event will be April of 2012 and that there is a start up fund for that. Selectman Bowles explained that at town meeting there was an article to raise and appropriate \$10,000.00 to get the initial start up and from then on the money will be raised from stickers. Chairman Ives asked if there was any further discussion, hearing none he took a vote. All were in favor. Motion carries. Chairman Ives closed the public hearing at

Selectman Bowles moved to go in to an executive session at 7:13 p.m.; seconded by Selectman Krieger. Roll call vote: Krieger yes; Bowles – yes; Ives – yes. All in favor. Motion carried. Present were Selectmen Ives, Bowles and Krieger. Selectman Krieger moved to come out of executive session at 7:24 p.m.; seconded by Selectman Bowles. Roll call vote: Krieger – yes; Bowles – yes; *Ives – yes.* Chairman Ives stated that the purpose of the executive session was to discuss two letters from two attorneys representing two town employees. These are two individual cases: both letters were received this week. Selectman Bowles made a motion to seal the minutes for five years, seconded by Selectman Krieger. Roll call vote: Krieger yes; Bowles – yes; Ives – yes. All in favor. Motion carried.

Selectman Bowles moved to adjourn the meeting at 7:25 p.m.; seconded by Selectman Krieger. All were in favor. Meeting adjourned.

Mr. Prescott said that it was felt that it was not feasible with the amount of traffic at that location. 3) Miles Smith Farm event on October 9th from 10-4; 4,000 people are expected and there will be two shuttle buses

# Zoning Board Minutes — September 22, 2011

Vice Chairman Ned Lizotte called the meeting to order at 7:00 p.m.

#### ROLL CALI

The following members were present: George Saunderson, Roy Merrill, Howard Pearl, Vice Chairman Ned Lizotte, and Alternates Jim Venne, Earl Tuson, and Jonathan Huntington

Jim Venne was appointed to be a voting member in the absence of Dave Powelson.

#### ACCEPTANCE OF MINUTES

**Regular Hearing** — Howard Pearl made a motion to accept the minutes of August 25, 2011 as presented; seconded by George Saunderson. All were in favor.

Site Visit — Maratea — Howard Pearl made a motion to accept the minutes of the site visit on September 7, 2011 as presented; seconded by George Saunderson. All were in favor.

#### DISCUSSION

Web Stout — proposed recycling facility — Mr. Stout, of FWS Land Surveying, stated that he is representing John Raymond who is interested in putting a recycling facility on property off Dump Road owned by David Moody. Mr. Raymond and Mr. Moody were present. Also present was Jeff Green of JL Green Enterprises who has done previous survey work on the Moody property.

Mr. Stout showed plans of where the proposed facility would be located on the parcel, noting that there are multiple lease areas on one big lot. He said the existing scale house would be revamped and the existing road would be used with a circular drive in this particular area. Mr. Stout pointed out that there are a couple of proposed covered areas and a larger area of outside storage. He noted that a special exception would be needed per Section 206.3 E of the Zoning Ordinance.

Board members asked questions regarding cement pads, onsite crusher, noise, traf-

fic, fluids disposal, and required State permits. Mr. Raymond explained an impervious surfaced area where all fluids would be removed from recycled items, where and how the fluids would be stored until removed by a professional company. He pointed out the area where white goods, iron, etc would be kept in an outside area. Mr. Raymond said there would not be a crusher onsite. He explained that the facility would service local electricians and plumbers, as well as residents, for the disposal of copper, machinery, white goods, cars, and other assorted metals. Mr. Raymond said he would be paying for metal but would not detract from the transfer station as anyone coming into his facility is now going elsewhere. He said this is not the typical household metal of tin cans, aluminum cans, etc. Mr. Raymond said his facility would target peddler scrap/small businesses and larger accounts such as Waste Management. The metal ends up at an out-of-state shredder. Mr. Raymond explained the entire process to the Board.

It was agreed by some Board members that they would like more information on what is required by the State for this type of facility. When individually polled, Board members were not opposed to hearing a formal application in order to get more information on the requirements from the State for this type of facility and how the application would meet zoning criteria for the proposed location off of Dump Road.

#### PUBLIC HEARING

Z11-07, Dianne D Maratea — Special Exception for Reduced Side & Front Setback, Map 58, Lot 17, RR District, 20 Berry Road. There were no abutters present. Tony Merullo represented the applicant.

Mr. Merullo went through the points of the application, noting that the request is for reduced front and side setbacks. Because of the lot size and configuration the proposed shed location would provide a 7' front setback and a 23' side setback.

The hearing was closed to the public and opened to the Board only. There were no questions from the Board. Roy Merrill made a motion to approve the application as presented; seconded by Howard Pearl. A roll vote was taken: Howard Pearl – yes; Roy Merrill – yes; Ned Lizotte – yes; George Saunderson – yes; Jim Venne – yes. Unanimous – APPROVED.

#### **BOARD DISCUSSION**

Building permit extension — Shawn Lavoie — A request was received from Mr. Lavoie to renew his expired building permit #08-024. The permit was extended in November 2008 for one year. Mr. Lavoie has begun construction of the home, thinking that the permit was still valid. This was brought to the Building Department's atten-


