**NOTICE OF
PUBLIC HEARING**

The Commission, in accordance with RSA 230:14 and the Surface Transportation and Uniform Relocation Assistance Act of 1987, has set a public hearing to discuss proposed improvements to NH Route 106 in the Towns of Loudon and Canterbury

The meeting will be held at the **Loudon Community Building, 29 S. Village Road, Loudon, NH on October 23, 2017 at 6:30 P.M.**

THE LOUDON COMMUNITY BUILDING WILL BE OPEN ONE HALF (1/2) HOUR PRIOR TO THE TIME OF THE HEARING FOR THE INSPECTION OF PLANS BY ANY INTERESTED PERSONS.

On June 7, 2017, the Governor and Executive Council appointed John Brady, Thomas Richardson, and George Saunderson as the Commission to conduct a Public Hearing to determine whether there is the occasion for the laying out of this project and acquiring necessary right-of-ways.

We, the Commission, hereby give written Notice to said Petitioners and the owners of land over which said highway may pass, and to all others interested by posting a like copy in at least two (2) public places in the Towns of Loudon and Canterbury, NH and leaving a like copy with the Town Clerks at least fourteen (14) days before the said day of hearing.

Relocation assistance will be furnished to each owner or tenant whose improvements or property will be acquired for this project based on their eligibility.

Interested landowners, local officials and highway users are welcome and will be given the opportunity to express their comments relative to the project. The testimony will be recorded.

This project may impact historic properties. This project is tentatively scheduled for advertising for bids February 13, 2018.

Maps, plans, the environmental studies and other pertinent information developed by the Department, along with written views received as a result of the coordination with other agencies, are available at the Department of Transportation at the John O. Morton Building, 7 Hazen Drive, Concord, New Hampshire for inspection and copying. It is suggested you call Keith Cota, Project Manager, at (603) 271-1615 in advance for an appointment.

Written statements and other exhibits may be submitted to the Chairman of the Commission, c/o Peter E. Stamnas, Director of Project Development, NH Department of Transportation, PO Box 483, Concord, NH 03302-0483 up to ten (10) days after the date of the hearing for inclusion in the official record.

NOTICE OF PUBLIC HEARING

- P E T I T I O N -

To His Excellency, the Governor, and the Honorable Executive Council:

In accordance with RSA 230:14, I, Victoria F. Sheehan, Commissioner of the New Hampshire Department of Transportation, propose that improvements be made to NH Route 106 at the location given below:

LOUDON-CANTERBURY, 29613

This project will widen NH Route 106 to improve highway safety and mobility. The widened highway will provide two 12' wide travel lanes, a continuous left turn lane, and 12' wide shoulders. The construction will begin approximately 0.1 miles south of Soucook Lane in Loudon and extend north approximately 3.4 miles to a point 0.5 miles north of Asby Road in Canterbury.

Therefore, in accordance with RSA 230:14, I, Victoria F. Sheehan, Commissioner of the New Hampshire Department of Transportation, propose that such alterations be made to NH Route 106 in the Towns of Loudon and Canterbury.
